(a)(1)(A) There is created the Arkansas State Board of Acupuncture and Related Techniques and Naturopathic Medicine.

(B) The board shall consist of five (5) persons appointed by the Governor as full members and one (1) person appointed by the Governor as an ex officio member.

SECTION 3. DO NOT CODIFY. <u>The Arkansas Code Revision Commission shall</u> <u>replace the name "Arkansas State Board of Acupuncture and Related Techniques"</u> <u>in all appropriate sections of the Arkansas Code with the name "Arkansas</u> <u>State Board of Acupuncture and Related Techniques and Naturopathic Medicine".</u>
