Subtitle of Senate Bill No. 112

AN ACT FOR THE DEPARTMENT OF HUMAN SERVICES - DIVISION OF DEVELOPMENTAL
DISABILITIES SERVICES APPROPRIATION FOR THE 2014-2015 FISCAL YEAR.

Amendment No. 1 to Senate Bill No. 112

Amend Senate Bill No. 112 as originally introduced:

Page 6, line 23, delete "6,752,051" and substitute "6,852,051"

AND

Page 6, line 29, delete "\$164,973,532" and substitute "\$165,073,532"

AND

Insert an additional SECTION immediately following SECTION 10 of the bill to read as follows:

" SECTION 11. APPROPRIATION - VOLUNTEER AND LEADERSHIP DEVELOPMENT GRANT. There is hereby appropriated, to the Department of Human Services - Division of Developmental Disabilities Services, to be payable from the paying account as determined by the Chief Fiscal Officer of the State, for a volunteer and leadership development grant for the fiscal year ending June 30, 2015, the following:

(01) VOLUNTEER AND LEADERSHIP DEVELOPMENT GRANT	<u>\$100,000</u> "

AND

Insert an additional SECTION immediately following SECTION 16 of the bill to read as follows:

" SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL, AND TEMPORARY LAW. EARLY INTERVENTION DAY TREATMENT.

(a)(1) Until the requirement in subsection (b) has been met, the Department of Human Services, including without limitation the Division of Developmental Disabilities Services and the Division of Medical Services, shall not enter any arrangement, contract for any services, commit any funds,



make any fund transfers, interagency or otherwise, or allocate any resources by any means to support the screening, assessment, evaluation, or treatment of the early intervention day treatment needs of a Medicaid-eligible child from birth to age five (5) by an academic medical center or any third party contractor.

(2) As used in this section, "early intervention day treatment" has the same meaning as defined in Arkansas Code § 20-48-1102(5).

(b) The House Committee on Public Health, Welfare and Labor, Senate Committee on Public Health, Welfare and Labor and the Administrative Rules and Regulations Subcommittee of the Legislative Council shall review the proposed arrangement, contract, fund commitment, fund transfer, or resource allocation and all materials related to the development and implementation plans of the proposed arrangement, contract, fund commitment, fund transfer, or resource allocation, including without limitation data and cost-benefit analysis justifying the cost.

(c) Implementation of the new early intervention day treatment program shall begin at the later of:

(1) Ninety (90) days after the publication of proposed program rates; or

(2) January 1, 2015."

AND

Appropriately renumber the SECTION numbers of the bill.
