
Page 1, delete lines 19 through 25, and substitute the following: "SECTION 1. Arkansas Code § 23-112-317 is amended to read as follows: 23-112-317. Motor vehicle dealer service and handling fees. (a) A motor vehicle dealer may <u>charge a service and handling fee in</u> <u>connection with the sale or lease of a new or a used motor vehicle to</u> fill in the blanks on standardized forms <u>and prepare documents relating to the</u> <u>closing of a sale or lease</u> in <u>connection with the sale or lease of a new or a</u> <u>used motor vehicle if the motor vehicle dealer does not charge for the</u> <u>service of filling in the blanks or otherwise charge for preparing documents</u>. The service and handling fee shall be no more than twenty dollars (\$20.00)."

AND

Page 2, delete lines 3 through 7, and substitute the following:
 "(2)(b) If a service and handling fee is charged under this
section, the service and handling fee shall be:
 (A)(1) Charged to all retail customers; and
 (B)(2) Disclosed on the retail buyer's order form as a
separate itemized charge."

AND

Page 2, delete lines 29 through 34, and substitute the following:



"SECTION 2. Arkansas Code § 23-112-617 is amended to read as follows: 23-112-617. Used motor vehicle dealer service and handling fee. (a) A used motor vehicle dealer may <u>charge a service and handling fee</u> <u>in connection with the sale or lease of a new or a used motor vehicle to</u> fill in the blanks on standardized forms <u>and prepare documents relating to</u> <u>the closing of a sale or lease</u> <u>in connection with the sale or lease of used</u> <u>motor vehicles if the motor vehicle dealer does not charge for the service of</u> <u>filling in the blanks or otherwise charge for preparing documents. The</u> <u>service and handling fee shall be no more than twenty dollars (\$20.00).</u>"

AND

Page 2, delete lines 20 through 25, and substitute the following: ""A SERVICE AND HANDLING FEE IS NOT AN OFFICIAL FEE. A SERVICE AND HANDLING FEE IS NOT REQUIRED BY LAW BUT MAY BE CHARGED TO THE CUSTOMER FOR PERFORMING SERVICES AND HANDLING DOCUMENTS RELATING TO THE CLOSING OF A SALE OR LEASE. THE SERVICE AND HANDLING FEE MAY RESULT IN PROFIT TO THE DEALER. THE SERVICE AND HANDLING FEE DOES NOT INCLUDE PAYMENT FOR THE PREPARATION OF LEGAL DOCUMENTS. THIS NOTICE IS REQUIRED BY LAW.""

Page 3, delete lines 12 through 16, and substitute the following:
 "(2)(b) If a service and handling fee is charged under this
section, the service and handling fee shall be:
 (A)(1) Charged to all retail customers; and
 (B)(2) Disclosed on the retail buyer's order form as a
separate itemized charge."
