Page 14, line 34, insert the following new SECTIONS immediately following SECTION 35 to read as follows:

" SECTION 36. ARKANSAS WINE GRANTS PROGRAM. There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the Arkansas Wine Grants Fund, for grants to wineries as provided by Arkansas Code § 19-6-839(b), for the fiscal year ending June 30, 2018, the following:

SECTION 37. ARKANSAS WINE GRANTS PROGRAM. There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the Arkansas Wine Grants Fund, for grants to wineries as provided by Arkansas Code § 19-6-839(b), for the fiscal year ending June 30, 2019, the following:

Page 35, line 12, insert a new SECTION immediately following SECTION 75 to read as follows:



"SECTION 76. EMERGENCY CLAUSE. (a) It is found and determined by the General Assembly of the State of Arkansas that section 36 of this act regarding the Wine Grants Program authorizing the DFA - Disbursing Officer to distribute grants to Arkansas wineries pursuant to Arkansas Code § 19-6-839(b) requires immediate implementation to ensure the operations of the agency are not interrupted or impaired. Therefore, an emergency is declared to exist, and section 36 of this act being immediately necessary for the preservation of the public peace, health, and safety shall become effective on:

- (1) The date of its approval by the Governor;
- (2) If the bill is neither approved nor vetoed by the Governor, the expiration of the period of time during which the Governor may veto the bill; or
- (3) If the bill is vetoed by the Governor and the veto is overridden, the date the last house overrides the veto."
