Page 1, line 9, delete "AND" and substitute "TO DECLARE AN EMERGENCY; AND"

AND

Delete the subtitle in its entirety and substitute:

"TO CREATE THE TEACHER SALARY
ENHANCEMENT ACT; AND TO DECLARE AN
EMERGENCY."



AND

Immediately following SECTION 2 of the bill, add an additional section to read as follows:

"SECTION 3. EMERGENCY CLAUSE. It is found and determined by the General Assembly of the State of Arkansas that there exists a shortage of licensed teachers in many areas of the state; that teacher salaries are a key factor in attracting individuals to the field of teaching; and that the provisions of this act should become effective at the beginning of the fiscal year to allow for implementation for the 2019-2020 school year. Therefore, an emergency is declared to exist, and this act being necessary for the preservation of the public peace, health, and safety shall become effective on July 1, 2019."
