Page 3, line 1, delete " $\underline{(H)}$ " and substitute " $\underline{(G)}$ "

Page 3, delete line 6, and substitute the following:
"minor is enrolled or from which the minor receives services shall then immediately notify:"

Page 3, delete lines 9 through 12, and substitute the following:

"(iii) Any other school official with a legitimate educational interest in the minor."

AND

Page 4, delete lines 20 and 21, and substitute the following:
"superintendent of the school district to which the minor transfers, in which the minor is enrolled, or from which the minor receives services."

AND

Page 4, line 23, delete " $\underline{is\ enrolled}$ " and substitute " $\underline{is\ enrolled\ or\ from}$ which the minor receives services"

AND

Page 4, delete lines 28 through 31, and substitute the following:

"(c) Any other school official with a legitimate educational interest in the minor."

AND

Page 5, delete lines 19 and 20, and substitute the following:
"and the principal of the school district to which the minor transfers, in which the minor is enrolled, or from which the minor receives services."

AND

Page 5, delete line 26 through 36, and substitute the following: "district to which the minor transfers, in which the minor is enrolled, or from which the minor receives services.

(3) A school official who receives a court order and safety plan"

Page 7, delete lines 3 and 4, and substitute the following:

"superintendent of the school district to which the juvenile transfers, in which the juvenile is enrolled, or from which the juvenile receives services."

"the designee of the school superintendent of the school district to which the juvenile transfers, in which the juvenile is enrolled, or from which the juvenile receives services if the juvenile is adjudicated delinquent"

AND

Page 7, delete lines 35 and 36, and substitute the following:
"designee of the superintendent of the school district to which the juvenile transfers, in which the juvenile is enrolled, or from which the juvenile receives services of the offense for which the juvenile was arrested or"

AND

Page 8, delete lines 3 and 4, and substitute the following:

"(2)(A) The superintendent of the school district to which the juvenile transfers, in which the juvenile is enrolled, or from which the juvenile receives services shall then immediately notify the principal"

AND

Page 8, delete lines 9 through 12, and substitute the following:

"(iii) Any other school official with a legitimate educational interest in the juvenile."

AND

Page 8, line 15, delete "(ii)" and substitute "(ii)"

AND

Page 9, delete lines 15 and 16, and substitute the following:
"superintendent of the school district to which the juvenile transfers, in which the juvenile is enrolled, or from which the juvenile receives services."

AND

Page 9, line 18, delete "<u>is enrolled</u>" and substitute "<u>is enrolled or from</u> which the juvenile receives services"

AND

Page 9, delete lines 23 through 26, and substitute the following:

"(c) Any other school official with a legitimate educational interest in the juvenile."

AND

Page 10, delete lines 18 and 19, and substitute the following:
"and principal where the of the school district to which the juvenile transfers, in which the juvenile is enrolled, or from which the juvenile receives services."

AND

Page 10, delete lines 24 and 25, and substitute the following: "superintendent and principal where the of the school district to which the juvenile transfers, in which the juvenile is enrolled, or from which the juvenile receives services."

AND

Page 10, line 27, delete "is enrolled" and substitute "is enrolled or from which the juvenile receives services"

AND

Page 10, line 35, delete "<u>is</u> enrolled" and substitute "<u>is</u> enrolled <u>or from</u> which the juvenile receives services"
