## Amendment No. 3 to House Resolution 1023

Amend House Resolution No. 1023 as engrossed, H3/12/19 (version: 03/12/2019 9:52:11 AM)

Add Representatives Dotson and Gates as cosponsors of the resolution

AND

Page 1, delete line 27 and substitute the following:

"54.(a)(1) <u>Selection of membership positions on House committees for</u> <u>members-elect shall take place during the caucus of the entire House of</u> <u>Representatives-elect on the first Friday following the November General</u> <u>Election.</u>

54.(a)(2) Each standing committee shall consist of twenty (20)"

AND


Page 1, line 30, delete "<u>standing committee.</u>" and substitute "<u>standing</u> <u>committee.</u> A member may not serve on more than one (1) committee of the same <u>class.</u>"

AND

Page 2, delete line 16 and substitute the following: "by the close of business on the day of the committee"

AND

Page 2, delete lines 25 through 31 and substitute the following: <u>(D)(i)</u> The Speaker of the House shall have the authority to make adjustments to committee membership following the committee selection process only for the purpose of adjusting the majority to minority party ratio on the standing committees.



(ii) The adjustments to committee membership made by the Speaker shall not exceed placing eleven (11) members of the majority party on a twenty (20) member committee.

(iii) Final committee memberships shall be announced no later than the House Orientation held in December before a Regular Session."

AND

Page 4, line 9, delete "<u>choose a position</u>" and substitute "<u>choose a primary</u> <u>or alternate position</u>"

AND

Page 4, line 11, delete "<u>choose a position</u>" and substitute "<u>choose a primary</u> <u>or alternate position</u>"

AND

Page 4, line 14, delete "<u>all positions</u>" and substitute "<u>all primary and</u> <u>alternate positions</u>"

AND

Page 4, delete lines 17 through 22 and substitute the following:

"(C)(i) The Speaker of the House shall have the authority to make adjustments to committee membership following the committee selection process only for the purpose of adjusting the majority to minority ratio on the House Budget Committee, the Legislative Council, and the Legislative Joint Auditing Committee.

(ii) The adjustments to committee membership made by the Speaker shall not exceed the minimum necessary to ensure majority party membership exceeds minority party membership on the committees.

(iii) Final committee memberships shall be announced no later than the House Orientation held in December before a Regular Session."
