Amendment No. 1 to House Bill 1210

Amend House Bill No. 1210 as engrossed H1/26/21 (version: 1/26/2021 10:19:15 AM):

Add Senators Caldwell, Beckham, Gilmore, G. Leding, B. Sample, J. Sturch, D. Wallace as cosponsors of the bill

AND

Add Representatives Vaught, S. Berry, Bragg, Breaux, Coleman, C. Cooper, Eaves, Ennett, Eubanks, Fortner, Hollowell, Jean, Jett, Lynch, Magie, McNair, B. Smith, Wing, Womack as cosponsors of the bill

AND

Delete the title in its entirety and substitute:
"AN ACT TO AMEND THE MAKEUP OF THE STATE PLANT BOARD; TO REQUIRE GOVERNOR APPOINTMENT AND SENATE CONFIRMATION OF POTENTIAL MEMBERS; AND FOR OTHER PURPOSES."

AND

Delete the subtitle in its entirety and substitute:

"TO AMEND THE MAKEUP OF THE STATE PLANT BOARD; AND TO REQUIRE GOVERNOR APPOINTMENT AND SENATE CONFIRMATION OF POTENTIAL MEMBERS."

AND

Delete everything after the enacting clause and substitute the following:



- "SECTION 1. Arkansas Code § 2-16-206(a), concerning the State Plant Board, is amended to read as follows:
- (a) There is created and established a State Plant Board, composed of eighteen (18) nineteen (19) members, as follows:
- (1) Two (2) nonvoting members designated by the Vice President for Agriculture of the University of Arkansas or his or her designee;
- (2) A practical cotton grower, actively <u>and principally</u> engaged in the business <u>production of cotton</u>, to be appointed by the Governor <u>and</u> confirmed by the Senate;
- (3) One (1) member to represent the <u>fertilizer industry shall be</u> appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas Plant Food Association, actively engaged in the business, to be appointed by the Governor;
- (4) A practical rice grower, actively <u>and principally</u> engaged in the <u>business</u> <u>production of rice</u>, to be appointed by the Governor <u>and</u> confirmed by the Senate;
- (5) A practical horticulturist <u>or nurseryman</u>, actively <u>and principally</u> engaged in the business, to be elected by the Arkansas State

 Horticultural Society to be appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas State Horticultural Society and the Arkansas Green Industry Association;
- (6) A nurseryman practical corn, peanut, sorghum, turf, or wheat grower, actively and principally engaged in the business production of corn, peanuts, sorghum, turf, or wheat, to be elected by the Arkansas Green Industry Association to be appointed by the Governor and confirmed by the Senate;
- (7) A practical <u>seed soybean</u> grower, actively <u>and principally</u> engaged in the <u>business production of soybeans</u>, to be elected by the Arkansas Seed Growers Association to be appointed by the Governor and confirmed by the Senate;
- (8) A One (1) member representing pest control operator, operators actively engaged in the business, to be elected by shall be appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas Pest Management Association, Inc.;
- (9) A seed dealer, actively <u>and principally</u> engaged in the business, to be elected by the Arkansas Seed Dealers' Association to be appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas Seed Dealers' Association;
- (10) A seed grower, actively and principally engaged in the business, to be appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas Seed Growers Association;
- (10)(11) One (1) member representing the Arkansas Bureau of Standards retail or wholesale fuel industry to be appointed by shall be appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas Oil Marketers Association;
- (11)(12) A One (1) member representing pesticide manufacturer, manufacturers actively engaged in the business, to be elected by shall be appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas Crop Protection Association, Inc.;

(12)(13) One (1) member to represent the Arkansas Agricultural Aviation Association, to be elected by representing agricultural aviators to be appointed by the Governor and confirmed by the Senate from a list of at least two (2) names submitted by the Arkansas Agricultural Aviation Association;

(13)(14) One (1) member to represent the Arkansas Forestry
Association, to be elected by representing the forest sector shall be
appointed by the Governor and confirmed by the Senate from a list of at least
two (2) names submitted by the Arkansas Forestry Association;

(14)(15) Two (2) farmers actively and principally engaged in farming the production of corn, cotton, peanuts, rice, sorghum, soybeans, turf, or wheat in this state, appointed by the Governor and confirmed by the Senate;

(15)(16) One (1) representative of the livestock industry \underline{A} practical livestock producer, actively and principally engaged in the business production of livestock, to be appointed by the Governor and confirmed by the Senate; and

 $\frac{(16)}{(17)}$ One (1) representative of the forage industry \underline{A} practical forage grower, actively and principally engaged in the business production of forage, to be appointed by the Governor and confirmed by the Senate.

SECTION 2. DO NOT CODIFY. Remainder of term.

<u>Current members of the State Plant Board shall serve out the remainder of their terms and are not required to be replaced to meet the changes of this act."</u>
