AN ACT FOR THE DEPARTMENT OF EDUCATION - ARKANSAS SCHOOL FOR THE BLIND AND
ARKANSAS SCHOOL FOR THE DEAF APPROPRIATION FOR THE 2022-2023 FISCAL YEAR.

Amendment No. 1 to House Bill 1080

Amend House Bill No. 1080 as originally introduced:

Page 2, delete line 4 in its entirety

AND

Page 2, delete line 12 in its entirety

AND

Page 2, delete line 16 in its entirety

AND

Page 2, line 29, delete "101" and substitute with "98"

AND

Appropriately renumber all item numbers in SECTION 1

AND

Page 3, line 13, delete "\$4,124,271" and substitute "\$4,010,224"

AND

Page 3, line 15, delete "1,467,155" and substitute "1,425,078"

AND

Page 3, line 26, delete "\$7,241,810" and substitute "\$7,085,686"

AND



Page 5, immediately following SECTION 7, insert a new SECTION to read as follows:

" SECTION 8. APPROPRIATION - ARKANSAS SCHOOL FOR THE BLIND - CAPITAL IMPROVEMENT. There is hereby appropriated, to the Department of Education - Arkansas School for the Blind, to be payable from the Development and Enhancement Fund, the following:

(A) for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade, and repair of real property and facilities at the Arkansas School for the Blind campus, in a sum not to exceed.....\$15,000,000."

AND

Page 6, delete line 6 in its entirety

AND

Page 6, delete line 15 in its entirety

AND

Page 6, line 21, following "SPECIALIST" delete "2" and substitute "1"

AND

Page 6, line 36, delete "153" and substitute "150"

AND

Appropriately renumber all item numbers in SECTION 8

AND

Page 7, line 20, delete "\$6,677,679" and substitute "\$6,562,217"

AND

Page 7, line 22, delete "2,489,837" and substitute "2,445,395"

AND

Page 7, line 33, delete "\$11,140,819" and substitute "\$10,980,915"

AND

Page 8, immediately following SECTION 12, insert the following:

" SECTION 13. APPROPRIATION - ARKANSAS SCHOOL FOR THE DEAF - CAPITAL IMPROVEMENT. There is hereby appropriated, to the Department of Education -

Arkansas School for the Deaf, to be payable from the Development and Enhancement Fund, the following:

(A) for various maintenance, renovation, equipping, construction, acquisition, improvement, upgrade, and repair of real property and facilities at the Arkansas School for the Deaf campus, in a sum not to exceed.....\$15,000,000."

Appropriately renumber all SECTION numbers of the bill.
