## Amendment No. 1 to House Bill 1147

Amend House Bill 1147 as originally introduced:

Page 7, immediately following SECTION 14, insert the following:

" SECTION 15. APPROPRIATION - SECURITY. There is hereby appropriated to the Secretary of State, to be payable from the cash funds deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for security of the Arkansas State Capitol and grounds for the fiscal year ending June 30, 2025, the sum of......\$3,100,000.

SECTION 16. APPROPRIATION - SECURITY. There is hereby appropriated to the Secretary of State, to be payable from the cash funds deposited in the State Treasury as determined by the Chief Fiscal Officer of the State, for security of the Arkansas State Capitol and grounds for the fiscal year ending June 30, 2026, the sum of......\$3,100,000.

Page 7, immediately following SECTION 16, insert the following:

"SECTION 17. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. <u>FUNDING TRANSFER - SECURITY. Immediately upon the effective date of this</u> <u>section, the Chief Fiscal Officer of the State shall transfer on his or her</u> <u>books and those of the State Treasurer and the Auditor of the State the sum</u> <u>of three million, one hundred thousand dollars (\$3,100,000) from the General</u> <u>Revenue Allotment Reserve Fund to the cash fund deposited in the State</u> <u>Treasury to provide funds for security of the Arkansas State Capitol and</u> <u>grounds.</u>

The provisions for this section shall be in effect only from July 1, 2024 through June 30, 2025."

AND

Page 8, delete SECTION 19 in its entirety and insert the following:

11 SECTION 19. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a one (1) year period; that the effectiveness of this Act on July 1, 2026 is essential to the operation of the agency for which the appropriations in this Act are provided; with the exception that Sections 15 and 20 in this Act shall be in full force and effect from and after the date of its passage and approval; and that in the event of an extension of the Session, the delay in the effective date of this Act beyond July 1, 2026, with the exception that Sections 15 and 20 in this Act shall be in full force and effect from and after the date of its passage and approval, could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2026; with the exception of Sections 15 and 20 in this Act shall be in full force and effect from and after the date of its passage and approval."
