## Subtitle of Senate Bill 434

TO CREATE THE "PROTECT OUR CONSTITUTION ACT"; AND TO AMEND A PORTION OF THE ARKANSAS CONSTITUTION AS AUTHORIZED BY ARKANSAS CONSTITUTION, ARTICLE 5, § 1.

## Amendment No. 1 to Senate Bill 434

Amend Senate Bill 434 as originally introduced:

Page 1, delete lines 10 through 16, and substitute the following: "CONCERNING THE PERCENTAGE OF VOTES REQUIRED FOR APPROVAL OF A CONSTITUTIONAL AMENDMENT REFERRED TO VOTERS UNDER ARKANSAS CONSTITUTION, ARTICLE 5, § 1; AMENDING ARKANSAS CONSTITUTION, ARTICLE 5, § 1, AS AUTHORIZED BY THAT PROVISION OF THE ARKANSAS CONSTITUTION; TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES."

AND

Delete the subtitle in its entirety and substitute:

"TO CREATE THE "PROTECT OUR CONSTITUTION ACT"; TO AMEND A PORTION OF THE ARKANSAS CONSTITUTION AS AUTHORIZED BY ARKANSAS CONSTITUTION, ARTICLE 5, § 1; AND TO DECLARE AN EMERGENCY."

AND



Page 1, delete lines 31 through 36, and substitute the following:

"SECTION 2. Pursuant to the authority granted by Arkansas Constitution, Article 5, § 1, the subsection of Arkansas Constitution, Article 5, § 1, titled "Majority" is amended to read as follows:

Majority. (a)(1) Any Except as provided in subdivision (a)(2) of this section, any measure submitted to the people as herein provided shall take effect and become a law when approved by a majority of the votes cast upon such measure, and not otherwise, and shall not be required to receive a majority of the electors voting at such election.

(2) A constitutional amendment submitted to the people as herein provided shall take effect and become a law when approved by at least twothirds (2/3) of the votes cast upon such measure.

(b) Such measures After a measure has been approved by a vote of the people, the measure shall be operative on and after the thirtieth day after the election at which it is approved, unless otherwise specified in the Aet measure.

(c) This section shall not be construed to deprive any member of the General Assembly of the right to introduce any measure, but no measure shall be submitted to the people by the General Assembly, except a proposed constitutional amendment or amendments as provided for in this Constitution.

SECTION 3. Pursuant to the authority granted by Arkansas Constitution, Article 5, § 1, the subsection of Arkansas Constitution, Article 5, § 1, titled "Conflicting Measures", is amended to read as follows:

Conflicting Measures. If conflicting measures initiated or referred to the people shall be approved by a majority of the votes severally cast for and against the same <u>as herein provided</u> at the same election, the one receiving the highest number of affirmative votes shall become law.

SECTION 4. <u>EMERGENCY CLAUSE.</u> It is found and determined by the <u>General Assembly of the State of Arkansas that amendments to the Arkansas</u> <u>Constitution impact the public peace, health, and safety of each citizen of</u> <u>this state; that to protect the public peace, health, and safety of the</u> <u>citizens of this state, it is necessary to increase the threshold for passage</u> <u>of a constitutional amendment proposed under Arkansas Constitution, Article</u> 5, § 1, to ensure that constitutional amendments are supported by an appropriate number of voters to justify an amendment to the Arkansas Constitution; and that this act should become effective at the earliest opportunity to ensure that its provisions are in place for the 2026 general election. Therefore, an emergency is declared to exist, and this act being immediately necessary for the preservation of the public peace, health, and safety shall become effective on:

(1) The date of its approval by the Governor;

(2) If the bill is neither approved nor vetoed by the Governor, the expiration of the period of time during which the Governor may veto the bill; or

(3) If the bill is vetoed by the Governor and the veto is overridden, the date the last house overrides the veto."
