Children's Hospital to deliver a statewide effort for health and developmental needs of children; reports are to be made annually to the Legislative Council. * Purchasing Definitions: Provides exemption from the State Purchasing Law for commodities & services procured through a group purchasing entity when substantial savings are available, with annual reporting to Div. of Legislative Audit. * <<u>Requested Change increases the max. number of vehicles to 94></u> Motor Vehicle Authorization: Modifies Arkansas Code to authorize 73 vehicles for UAMS. * Parking Fees: Requires payment each July 1 for War Memorial Stadium Commission Parking Services from Fees from non-general revenue to the War Memorial Stadium Commission *Medical Scholarships & Loans Transfer Provisions: Allows transfers between line items for Medical Scholarships & Loans * Positions: Modifies Arkansas Code to allow 1000 new or additional positions with DFA-OPM and Legislative Council approval should unanticipated funds for educational projects become available. * Fund Balances: Requires certification to the State CFO and the Legislative Council that, as of December 31 of each year, sufficient funds & appropriations are or will be available to meet all obligations; to be filed by February 28th or upon release of the previous year's audit by Leqislative Audit and to include the preceding fiscal year's financial statement. * Carry Forward: Allows for the carryforward of appropriations

made from tobacco settlement funds

* Children's Hospital: Ensures that Children's Hospital receives 1/3 of whatever funding is available for the Arkansas Biosciences Institute.

* Transfer Restrictions: Prohibits any transfers among tobacco settlement funds appropriations except as provided in the Act containing the appropriations.

* Transfer Provisions: Allows transfer of tobacco funds appropriations between line items with approval of the Chief Fiscal Officer of the State, Dept. of Higher Education & Legislative Council

* Positions: States that it is not the commitment of the State to continue any position funded from tobacco settlement funds if those funds become insufficient.

* Compliance: States fiscal control laws and regulations are to be complied with.

* Intent: States that disbursements are to be in accordance with Initiated Act 1 of 2000, budget manuals, and testimony relating to the appropriation act.
