- HB1630 AN ACT FOR THE DEPARTMENT OF FINANCE AND ADMINISTRATION - DISBURSING OFFICER - MISCELLANEOUS FEDERAL PROGRAM FUNDS AND PROVIDING STATE AGENCIES WITH APPROPRIATIONS FOR CASH FUNDS SUPPLEMENTAL APPROPRIATION.

**Bills to be considered which have been introduced by Representatives**

- HB1130 TO ALLOW THE LEGISLATIVE COUNCIL OR JOINT BUDGET COMMITTEE TO RECEIVE A MONTHLY REPORT FOR COMMODITIES CONTRACTS THAT INCLUDE SERVICES AND THAT HAVE A PROJECTED TOTAL COST OF \$250,000 OR MORE.
