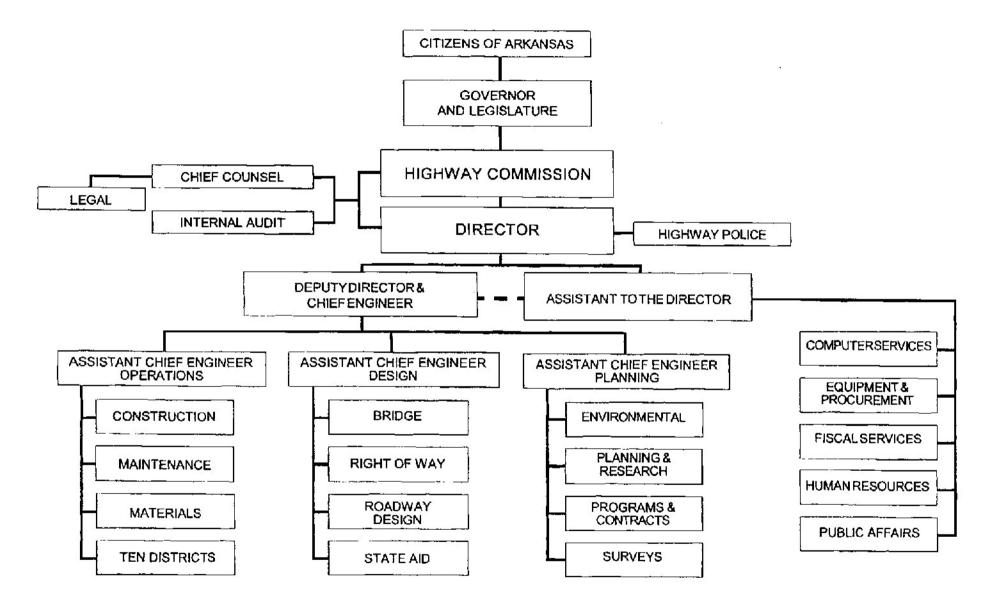

ARKANSAS BUDGET SYSTEM ANNUAL MISSION STATEMENT

History

A State Highway Commission was created by Act 302 of 1913 with the Commissioner of State Lands as Chairman, who appointed a State Highway Engineer subject to the approval of a three (3) member State Highway Commission. Act 65 of 1929 separated the State Highway Department from the office known as the Department of State Lands, Highways and Improvements and created the Highway Commission as separate body composed of five (5) members, one (1) from each of the four (4) agricultural school districts and one (1) from the State at large. Act 3 of 1933 repealed Act 65 of 1929 and created a new Highway Commission composed of five (5) members. Act 318 of 1935 provided for seven (7) Highway Commission Members, one (1) from each Congressional District. Act 42 of 1945 provided for (10) Highway Commission members, one (1) from each of the ten (10) maintenance districts. Act 239 of 1949 provided for twelve (12) Highway Commission members, one (1) from each of the (10) maintenance districts and two (2) from the State at large.

Constitutional Amendment No. 42, known as the Mack-Blackwell Amendment, created a State Highway Commission. The enabling legislation for this amendment was Act 123 of 1953. The Commission is vested with all the powers and duties now or hereafter imposed by laws for the administration of the Arkansas Highway and Transportation Department. The amendment provided for five (5) Highway Commission members appointed from the State at large; provided, however, that no two (2) Commissioners be appointed from any single Congressional District.

Act 192 of 1977, effective February 17, 1977, changed the name of the Arkansas State Highway Department to the Arkansas State Highway and Transportation Department. The purpose of this act is to effectuate the transportation policy by preparing and coordinating a comprehensive, balanced multi-modal transportation plan for the State including airways, highways, railways, waterways, bicycling, mass transit, and other transportation facilities, whether public or privately owned, developed, operated or maintained.

Act 1027 of 1999 authorized the Commission, upon voter approval, to issue up to \$575 million in bonds to finance an Interstate Highway Rehabilitation Program. The voters approved issuance of these bonds in a special election held in June of 1999. These bonds utilize a new federal program known as Grant Anticipation Revenue Vehicles or GARVEE's. The bonds are repaid primarily from future Federal Interstate Maintenance Funds and a 4¢ increase in the diesel fuel tax contained in Act 1028 of 1999.

Acts four (4) and five (5) of the 86th General Assembly 1st Extraordinary Special Session, 2008, amended the Natural Gas Severance Tax for the State of Arkansas. A majority of the increase shall be classified as Special Revenue and shall be distributed as set forth in the Arkansas State Highways Distribution Law, section 27-70-201 et seq.

ARKANSAS STATE HIGHWAY AND TRANSPORTATION DEPARTMENT SALARY REQUEST

As shown in the table below the Department has reduced authorized positions by 497 from 1991 through this proposed budget. This change corresponds with the trend or reducing the number of positions requested as shown in the table along with a summary of title and position changes. Not only has the Department shown a reduction in positions authorized but for this period of time we have reduced full-time employees by 339.

The upgrade for the Section Head-Beautification is based on increased responsibility attributed to the growth of the logo and permitting program. There has been an increase in the original billboard and logo program and additional programs and regulations as they relate to tourist directional signing, attraction signing as classified by Parks and Tourism, and the new billboard services offered by digital signing technology. In comparing this position with other Section Heads at a salary level XVIII, we feel an upgrade from salary level XVII is warranted.

The upgrade for Materials Technician I and Sign Maker I from salary level IV to salary level V is based on the difficulty of hiring qualified employees at salary level IV.

We are recommending that the Chief, of the Arkansas Highway Police, be upgraded to the status of Division Head. The current pay level this reflects an increase of \$5,772, our recommendation is that this position will no longer be eligible for the Uniform and Travel allowance of \$3,500 per year, netting an increase of \$2,272. Comparing the responsibilities of the Chief, of Highway Police, we feel that the title warrants the level of a Division Head.

There are currently three (3) employees performing the same duties in the Accounts Payable section, two (2) at a salary level VIII, and one (1) at a salary level VII. The duties and responsibilities being the same we are suggesting that the one employee at a salary level VII be paid at a salary level VIII, title of Account Analyst.

We are requesting a new title of "Title VI Coordinator" salary level XIV, the new title is needed due to additional requirements from the Federal EEO Agency in the Title VI program.

We are requesting a new title of Insurance Account Coordinator, these positions will coordinate the employee insurance programs for both Active and Retired employees of the Highway Department, the salary level and the job duties are in line with the title of EBD Benefit Specialist.

OVERTIME. The Arkansas Highway Commission is hereby authorized to pay overtime to its employees, and the administration thereof shall be in accordance with the policies established by the Commission. Overtime thus paid shall be identifiable for each employee, and in total for all employees, on the voucher or other record that is submitted to support the issuance of payroll warrants.
