I) AGENCY SUMMARY & REVENUE SOURCES

MISSION

The State Board of Collection Agencies (SBCA) regulates collection agency activities in Arkansas. Collection agencies must licensed if (a) they are located in Arkansas or (b) they contact consumers in Arkansas. The SBCA works to protect creditors who give their accounts to collection agencies to be collected and consumers who are being contacted by collection agencies. The board prevents undesirable collection activities, ensures compliance with Arkansas debt collection laws and educates Arkansas consumers of their rights when dealing with a collection agency.

The SBCA investigates consumer complaints of unfair or unconscionable collection practices, assessment of prohibited collection charges, and un-licensed activity.

TOTAL BIENNIAL BUDGET

The total budget is \$1,597,685 the first year and \$1,602,487 the second year of the biennium.

FUNDING SOURCE

The State Board of Collection Agencies is funded from the receipts of licensing fees received from collection agencies and fines imposed.

II) SIGNIFICANT CHANGES:

Appropriation for the Division of Check Cashing was discontinued pursuant to the ruling in *McGhee vs. Arkansas State Board of Collection Agencies*, Case No. 08-164, delivered November 6, 2008, the Arkansas Supreme Court held that the Check-cashier's Act, A.C.A. 23-52-101 et seq., was unconstitutional in its entirety.

IV) SPECIAL LANGUAGE:

Pursuant to A.C.A. 17-24-305, each fiscal year the first \$115,000 of Collection Agencies licensing fees collected will be remitted to the Department of Human Services - Division of Medical Services, additional funds collected in an amount not to exceed \$600,000 shall be remitted to UAMS - College of Pharmacy and the College of Nursing. Additional funds collected in an amount not to exceed \$250,000 shall be remitted to the ASU-Mountain Home Practical Nurse Program. Additional funds collected in an amount not to exceed \$100,000 shall be remitted to the University of Central Arkansas - Department of Nursing. Additional funds collected in an amount not to exceed \$100,000 shall be remitted to the Southern Arkansas University for personal services and operating expenses of the Southern Arkansas University System.

New Special Language: funding transfer provides all unexpended balances received by the Division of Check Cashing under the Check-Cashers Act shall be remitted as follows: the first fifty thousand (\$50,000) to the Housing Trust Fund, all remaining funds shall be distributed equally among the Arkansas State University Fund, the Mid-South Community College Fund and the University of Arkansas at Little Rock Fund.
