**I) AGENCY SUMMARY & REVENUE SOURCES**

**MISSION**

The Workers' Compensation Commission (WCC) administers and enforces the Arkansas Workers' Compensation Law to ensure that all covered employers secure insurance coverage from commercial carriers or through self-insurance programs and adjudicates all work related injury claims by employees against their employers or insurance carriers. The WCC laws are designed to protect employers, employees, and their dependents from financial burdens imposed by job-related injury and disease. In addition, the AWCC regulates workers' compensation awards to insure that benefit providers make correct and timely payments to eligible claimants.

**TOTAL APPROPRIATION**

The total appropriation for the Commission is \$201,101,803 for FY2012 and \$201,226,822 for FY2013, which is an increase of \$71,476 and \$196,495, respectively.

**FUNDING SOURCES**

The appropriations for the WCC are funded by a 3% premium tax on worker's compensation insurance premiums (credited to 3 Trust Funds: Second Injury Trust Fund, Death and Permanent Total Disability Trust Fund, and the Workers' Compensation Fund) and Cash Funds from seminar receipts (approx. .06% of total funding).

**II) SIGNIFICANT CHANGES**

**Purchase Annuities (APPROPRIATION 113)**

This appropriation has been used to allow the Death and Permanent Total Disability Trust Fund (funded by a 3% Premium Tax) to provide for claimants or beneficiaries through the purchase of structured annuity contracts from insurance companies. The base level appropriation is \$4 million. **It is discontinued due to lack of participation. This appropriation was last used in FY1997-98.**

**Administration (APPROPRIATION 355)**

This appropriation is used to pay the general operating expenses of the Commission, and is funded by the 3% premium tax proceeds credited to the Workers' Compensation Trust Fund. The total appropriation is \$27,961,803 for FY2012 and \$28,086,822 for FY2013, which includes the following changes:

**Regular Salaries & Matching** - Provides for a net increase of \$148,776 for FY2012 and \$273,795 for FY2013 which is the result of:  
- Reduction of \$159,302 each year due to the discontinuation of 5 positions, no longer needed as a result of job duty consolidation  
- Increase of \$308,078 for FY2012 and \$433,097 for FY2013 for a cost of living increase.

**Operating Expenses** - Provides an increase of \$63,500 for increases in utilities (\$7,700), building and maintenance costs (\$38,050), debt service principle (\$1,750), office equipment maintenance (\$4,000), rent of facilities (\$3,500) and mileage/fuel costs (\$8,500).

**Capital Outlay** - Provides \$30,000 each year, for a new vehicle each year and for law library holdings.

**Computer Software/Hardware** - Provides \$182,700 in appropriation each year which is a **reduction** of \$170,800. The base level of \$353,500 is not required to maintain their Information Technology Plan.

**IV) SPECIAL LANGUAGE**

**DELETES THE FOLLOWING LANGUAGE - QUARTERLY REPORTS:** Requires the Commission to provide quarterly reports to Legislative Council and the House and Senate Public Health, Welfare and Labor Committees on the progress of the Health and Safety and the Medical Cost Containment Programs.

**INVESTMENTS:** Authorizes funds in the Death and Permanent Total Disability Trust Fund, Second Injury Trust Fund, and Workers' Compensation Trust Fund to be invested and reinvested in all such investments authorized for use by the Office of Treasurer, and provides the investments will be completed by fund transfer as directed by the Chief Executive Officer of the Workers' Compensation Commission.

**DELETES THE FOLLOWING LANGUAGE - WCC BUILDING APPROPRIATION**

**EXPENDITURE LANGUAGE:** The language requires Legislative Council approval for any expenditure, or any combination of expenditures that exceeds ten thousand dollars (\$10,000), from the Workers' Compensation Commission Building appropriation.
