HB 1484 makes technical corrections to Title 15 of the Arkansas Code concerning Economic Development as listed below. This bill also removes obsolete language and repeals obsolete sections of the Arkansas Code. These technical corrections and repeals of obsolete statutory language and sections of the Code include:

- Corrections related to the Division of Science and Technology of the Arkansas Economic Development Commission;
- Repeal of the section related to the tax credit allowed purchasers of common stock under the County and Regional Industrial Development Company Act; under the current law no credit is allowed for a tax year ending after December 31, 2006;
- Technical corrections related to the Inventors' Assistance Act;
- Technical corrections to the Arkansas Economic Development Incentive Act of 1993;
- Repeal of the Arkansas Workforce Investment Board and Adult Education Study Committee;
- Technical corrections to the Arkansas Workforce Innovation and Opportunity Act;
- Technical corrections to the Arkansas Development Finance Authority Act;
- Technical corrections to the Arkansas Development Finance Authority Bond Guaranty Act of 1985;
- Technical corrections to the Arkansas Development Finance Authority Small Business Act of 1989;
