I) AGENCY SUMMARY & REVENUE SOURCES MISSION

The purpose of this agency is to assist veterans and their dependents in securing their rights and benefits under federal and state laws. The agency provides assistance to the County Veterans Service Officers. The agency also maintains a Veterans Home - a 108 bed facility that opened in June of 2006 in Fayetteville. A facility in Little Rock was recently closed and all residents were transitioned into private residences and VA approved facilities. Currently, the Agency is in the process of establishing a new skilled and long term care residential facility to be located in North Little Rock. This facility is being completed and the agency's appropriation bill was amended to add additional staff and appropriation for startup costs and operating expenses associated with the new North Little Rock Home. The agency operates two State Veterans Cemeteries in North Little Rock and Birdeye.

TOTAL APPROPRIATION

The agency's total appropriation is \$18,558,423 for FY2018 and \$19,368,054 for FY2019.

FUNDING SOURCE

The budget is funded by general revenue and by fees for services and federal reimbursement.
