SPECIAL LANGUAGE REVISIONS

Code Amendment - New Section §20-77-912 - Funds for investigations and prosecutions - Under the Medicaid Fraud Act § 5-55-101 the Attorney General or prosecuting attorney is entitled to recover reasonable and necessary expenses incurred during its investigations and prosecutions.

Fund Transfer - changed language to say "the Attorney General <u>may</u> deposit or transfer by check <u>monies</u> from the unobligated cash funds of the Office of the Attorney General received from court orders or settlement agreements to the State Central Services Fund."

Fees - Section codified in statute § 25-16-716 and deleted from bill.
