The Arkansas Tobacco Control Board was created by Act 1337 of 1997 to regulate and issue permits and licenses for the sales of cigarettes or tobacco products in Arkansas. Act 1235 of 2015 added the regulation of vapor, alternative nicotine and e-liquid products to the Board's responsibilities. The agency may suspend or revoke permits and licenses but does not collect cigarette and tobacco taxes. It is funded with cash, general revenue, a grant from the Arkansas Department of Health using Master Tobacco Settlement monies for the sales to minors' checks and enforcement, and special revenue in the form of permit fees
