#### **SPECIAL LANGUAGE REVISIONS**

**Indigent Parent Counsel Representation** - New language for Public Defender moved from Administrative Office of the Courts that gives Parent Counsel the authority to enter into independent professional service contracts.

**Transfer Provision - Line Items - Commission for Parent Counsel -** New language - Allows the transfer between line items except Personal Services Matching.

**Extra Help Exemption - Commission for Parent Counsel** - New language - Allows concurrent employment within the agency.

Code Amendments to § 9-27-703 and § 9-27-704 - Changes to code deleting Administrative Office of the Courts and adding Public Defender Commission as the agency that Commission for Parent Counsel falls under. Also makes it so the Commission for Parent Counsel and the Arkansas Public Defender Commission work independent of one another.

Fee Generation and Support - Courts - Section codified in statute § 5-4-303 and deleted from bill.

Fee Generation and Support - Bail Bond Fees - Section codified in statute §17-19-301 and deleted from bill.

**Duties of Dependency-Neglect Appeals Attorney** - Language deleted

**Providing Public Defender Services Agreement**- Section codified in statute § 16-87-203(a) and deleted from bill.
