# 0790 – DEPARTMENT OF COMMERCE FISCAL YEAR 2021 LEGISLATIVE RECOMMENDATION

The Department of Commerce is composed of: Aeronautics, Arkansas Wine Producers Council, the Bank, Insurance and State Securities Departments, Development Finance Authority, Waterways Commission, Workforce Services (including Rehabilitation Services and Services for the Blind), and the Economic Development Commission (including Film, Grants Management, International Business, Rural Services, Science and Technology, and Small and Minority Business). Act 271 of 2017, the Arkansas Energy Office was transferred by a Type 2 transfer to the Department of Environmental Quality. **Per Act 910 of 2019** (the **Transformation and Efficiencies Act) the Office of Skills Development was transferred to the Department of Commerce and the Arkansas Unpaved Roads program was transferred to the Department of Agriculture.**

- Code amendment added removing the Office of Skills Development Fund from the Special Revenue Funds section of the Revenue Classification Law and adding it to the Miscellaneous Funds section of the Revenue Stabilization Law.
