The Department of the Inspector General was created by Act 910 of 2019. It houses the Office of Medicaid Inspector General, the Arkansas Fair Housing Commission, and the Internal Audit functions of the state (formerly part of the Department of Finance and Administration), along with the Shared Services for the department.
