## SPECIAL LANGUAGE REVISIONS

*DELETED LANGUAGE* Henderson State University and College of the Ouachitas Cooperative Agreement. The institution no longer requested this language because both institutions are now under the auspice of the ASU System.
*REVISED LANGUAGE* Loan. The special language removes mention of the mechanism through which Henderson State requested $\$ 6,000,000$ from the Budget Stabilization Trust Fund. It still mandates that this amount must be repaid by 2028 .
