The Department of Commerce - Arkansas Rehabilitation Services' (DOC - ARS) mission is to provide opportunities for individuals with disabilities to work and lead productive and independent lives. ARS provides statewide vocational rehabilitation services to disabled persons so they can return to or enter employment. ARS carries out its responsibilities through a field program that reaches all 75 counties through 19 field offices, the Arkansas Career Development Center (formerly the Arkansas Training Institute - ACTI), Business Engagement services, Access and Accommodations Programs, Transition and Support Services, and the Services for the Deaf and Hard of Hearing. In 2019, the Arkansas Kidney Disease Commission was transferred **to** the Department of Health and the State Services for the Blind was established to provide services to blind and severely visually impaired persons through a network of counselors and private service providers throughout the State.
