Existing code allows the university to pay up to one month's salary for athletic department and band personnel when engaged in postseason competition or achieving exceptional recognition - as long as the funding isn't from public funds.

\*Code amendment\* The amendment codifies the ability for ASMSA to compensate certain staff up to 1/10th their annual salary every summer month they work.
