SPECIAL LANGUAGE REVISIONS

- *Code amendment* The language codifies the purpose, rules, and grant process of the rural broadband development initiatives overseen by the UAMS Institute for Digital Health and Innovation.
- *Code amendment* The language updates statute to reflect the maximum special allowances for patient care and research faculty, which is 2.5 times a salary's line item maximum.
- *Code amendment* The language codifies allowing funds for the purpose of contracting with physicianteachers and teachers in other health-related professions residing only at sites located away from the UAMS main campus. The funds must be used to teach residents and students assigned to AHECs.
- *Code amendment* The language codifies overtime, incentives, and differentials for direct and indirect unclassified patient care personnel.
- *Code amendment* The language codifies the right to utilize appropriated funds to authorize procedures for the disbursement of indigent care maintenance and general operations appropriations to be paid from cash funds of UAMS, subject to reimbursement and correction of reporting.
- *Code amendment* The language codifies on-call compensation limits of up to 128 hours in a week for patient care employees and permits UAMS to pay patient care employees compensation when there is no regularly scheduled staff coverage.
- *Code amendment* The language codifies the memorandum of understanding between UAMS and DHS regarding the State Olmstead plan.
