# SPECIAL LANGUAGE REVISIONS

**Investment Authority.** This language allows the Worker's Compensation to invest funds at their discretion with the State Treasurer. This language is recommended for codification.

**Fund Transfers.** After receiving approval from the Chief Fiscal Officer of the state and after all claims are expired, the Worker's Compensation Commission may transfer any remaining funds from the Second Injury Trust Fund to the Death and Permanent Total Disability Trust Fund or the Worker's Compensation Fund. This language is recommended for codification.
