Bill: HB1422 Amendment Number: H1 Bill Subtitle: TO CREATE THE ONLY CITIZENS VOTE ACT; TO AMEND THE LAW CONCERNING THE DRIVER'S LICENSES OF CERTAIN NONCITIZENS; AND TO AMEND ARKANSAS CONSTITUTION, AMENDMENT 51, SECTION 13.

Basic Change:

House Amendment No. 1 --- HB1422-H1 amends the Only Citizens Vote Act to make the original bill's provisions applicable to a driver's license issued to certain noncitizens equally applicable to an identification card issued to certain noncitizens.

HB1422-H1 removes from existing law certain categories of documents and identification cards that may be accepted for voter identification purposes, including:

- A concealed handgun carry license;
- An employee badge or identification document issued by an accredited postsecondary educational institution in the state; and
- A public assistance identification card if the card shows a photograph of the person to whom the document or identification card was issued.

HB1422-H1 additionally adds a requirement that the Secretary of State:

- Refer to the Attorney General for prosecution any person with a noncitizen driver's license or identification card who is found to be registered as a voter:
- Direct the county clerk cancel the person's voter registration.

The Secretary of State is required to provide notice to the individual, which must include the opportunity for the individual to provide evidence or documentary proof of United States citizenship and provide by rule a process for a person to contest the cancellation of voter registration.

HB1422-H1 is effective on and after January 1, 2026.

Original Bill --- HB1422 creates the "Only Citizens Vote Act", which amends the contents and use of a driver's license for certain noncitizens.

Under current law, an individual with a valid, unexpired nonimmigrant visa or nonimmigrant visa status for entry into the United States may obtain a driver's license. HB1422 provides that such a driver's license is to expire no later than the expiration date of the valid, unexpired nonimmigrant visa or nonimmigrant visa status for entry into the United States. HB1422 makes several changes regarding the content and appearance of a driver's license issued to a noncitizen:

- The license must display the phrase "Non-Citizen";
- The license must display the phrase "Not valid for federal identification purposes or voter identification purposes"; and

• The license must be distinct in appearance and printed in vertical or portrait format.

HB1422 provides that a driver's license issued to a noncitizen is not valid for purposes of certain voter registration requirements.

HB1422 additionally requires the Department of Finance and Administration (DFA) to provide a monthly report to the Secretary of State listing the names and identifying information of each individual holding a noncitizen's driver's license. The Secretary of State is required to utilize the list to determine whether any of the individuals are registered to vote. If any of the individuals are registered to vote, the Secretary of State is required to notify the clerk of the county where the individual is registered to vote so that the clerk may cancel the individual's voter registration. The Secretary of State is also required to provide DFA with a list of individuals whose voter registration is canceled so that DFA may immediately suspend the individual's driving privileges.

Fiscal Impact:

None.

Taxpayer Impact:

A noncitizen holding a driver's license or state-issued identification card that is registered to vote in the State of Arkansas will have his or her voter registration canceled.

Resources Required:

The Arkansas Integrated Revenue System (AIRS) Driver Services/Motor Vehicle (DSMV) will need to be modified at a project cost of \$152,000

Time Required:

Adequate time is provided for implementation.

Procedural Changes:

Updates will be required to the Office of Motor Vehicle (OMV) manual and the DFA website. Training and review sessions will be conducted for State Revenue Office, Office of Driver Services, and Office of Motor Vehicle employees and staff. Notification will also be provided to the taxpayer community.

Other Comments:

None.

Legal Analysis:

House Amendment No. 1 --- HB1422-H1 resolves the issue noted in the original bill by providing that a driver's license or identification card issued under the provisions of the Motor Vehicle Driver's License Act shall expire no later than:

• The expiration date of the documentary evidence of a person's lawful status provided by the applicant; or

• The period provided for in § 27-16-1111, which provides that a holder of a nonimmigrant visa may be allowed an additional 240 days if the applicant presents a valid Form I-797C.

Original Bill --- HB1422 amends § 27-16-801(a)(1) of the Motor Vehicle Driver's License Act to provide that a driver's license issued to a person who has a valid, unexpired nonimmigrant visa or nonimmigrant visa status for entry into the United States shall expire no later than the expiration date of the valid, unexpired nonimmigrant visa or nonimmigrant visa status for entry into the United States. HB1422 may benefit from an amendment clarifying whether this provision is intended to supersede § 27-16-1111, which provides that a holder of a nonimmigrant visa may be allowed an additional 240 days if the applicant presents a valid Form I-797C, Notice of Action. An I-797C, Notice of Action is a form issued by the U.S. Citizenship and Immigration Services that advises an applicant of the status of an application regarding immigration status.
