# **Impact Assessment for HB1763 Sponsored by Representative Underwood**

### Subtitle TO CREATE THE OFFENSE OF UNLAWFUL USE OF A COMMUNICATION DEVICE DURING THE COMMISSION OF A HUMAN TRAFFICKING OFFENSE.

Impact Summary<sup>1</sup> Minimal. While the proposed bill creates a new felony criminal offense for which the likely number of occurrences is unknown, there only four (4) offenders serving a sentencing for A.C.A. § 5-64-404, Unlawful use of a communication device, as the most serious offense.

Change from Current Law<sup>2</sup> Amends Title 5 of Arkansas Code Annotated (A.C.A.) by adding a new section A.C.A. § 5-18-108, Unlawful use of a communication device during the commission of a human trafficking offense. Under the proposed bill, a violation of A.C.A. § 5-18-108 is a Class C felony. Under current law, a violation of A.C.A. § 5-64-404, Unlawful use of communication device, is a Class C felony that shares a similar course of conduct with the proposed new offense [See attached for complete reproduction]

**Impact Information** The proposed bill creates a new felony offense, the likely number of occurrences of which cannot be determined. The proposed criminal offense contains similar elements with A.C.A. § 5-64-404, Unlawful use of communication device. The following data is for informational purposes only.

The Administrative Office of the Courts (AOC) reports that for the three (3) year period beginning January 1, 2022 and ending December 31, 2024, there were two-hundred fifty-three (253) felony convictions for a violation of A.C.A. § 5-64-404, Unlawful use of communication device.

The Division of Correction (ADC) reports that there are currently four (4) offenders serving a sentence for A.C.A. § 5-64-404, Unlawful use of a communication device, as the most serious offense.

Due to the low number of affected offenders, the potential impact on correctional resources is projected to be minimal.

#### **5-64-404**. Use of a communication device.

(a)

(1) As used in this section, "communication device" means any public or private instrumentality used or useful in the transmission of a writing, sign, signal, picture, or sound of any kind.

(2) "Communication device" includes mail, telephone, wire, radio, and any other means of communication.

(b) A person commits the offense of unlawful use of a communication device if he or she knowingly uses any communication device in committing or in causing or facilitating the commission of any act constituting a:

(1) Felony under this chapter; or

(2) Felony inchoate offense under § 5-3-101 et seq. or this chapter.

(c) Each separate use of a communication device is a separate offense under this section.

(d) Any person who violates this section upon conviction is guilty of a Class C felony.
