3	REQUESTING THE ARKANSAS LEGISLATIVE COUNCIL TO EXPRESS OPPOSITION
4	TO THE CORONAVIRUS 2019 (COVID-19) VACCINE MANDATES ESTABLISHED
5	BY THE CENTER FOR MEDICARE AND MEDICAID SERVICES AND SUPPORT FOR
6	THE ATTORNEY GENERAL'S LITIGATION CONCERNING THE MANDATE.
7	
8	WHEREAS, the Centers for Medicare and Medicaid Services established the
9	Interim Final Rule with Comment Period regarding coronavirus 2019 (COVID-19)
10	vaccination requirements for staff at Medicare- and Medicaid-certified
11	providers and suppliers on November 5, 2021; and
12	
13	WHEREAS, this interim final rule has an effective date of November 5,
14	2021, and a public comment period that ends on January 4, 2022; and
15	
16	WHEREAS, this interim final rule requires employees and staff for
17	Medicare- and Medicaid-certified providers and suppliers, including
18	hospitals, dialysis facilities, ambulatory surgical settings, home health
19	agencies, and nursing homes, to receive the coronavirus 2019 (COVID-19)
20	vaccination to maintain Medicare and Medicaid reimbursement; and
21	
22	WHEREAS, several state Attorney Generals, including Arkansas, have
23	joined together to file a lawsuit on November 10, 2021, in a federal court in
24	Missouri challenging this interim final rule; and
25	
26	WHEREAS, this interim final rule could cause a significant shortage of
27	healthcare professionals in the State of Arkansas, negatively impact the
28	health of the citizens of Arkansas, and further strain the delivery of
29	healthcare in rural parts of the state and healthcare provided to the most
30	vulnerable populations;

32	NOW THEREFORE,
33	BE IT RESOLVED BY THE ARKANSAS LEGISLATIVE COUNCIL OF THE NINETY-THIRD
34	GENERAL ASSEMBLY:
