27	SECTION 1. Arkansas Code Title 9, Chapter 4, is amended to add an
28	additional subchapter to read as follows:
29	<u>9-4-201. Title</u>
30	This subchapter shall be known and may be cited as the "Spousal Abuse
31	Safety Plan and Education Act".

33	<u>9-4-202. Findings</u>
34	The Arkansas General Assembly finds that the Spousal Abuse Safety Plan
35	and Education Act is needed to:
36	(1) Protect victims and children;



1	(2) Develop increased security measures necessary to provide
2	greater protection for victims of spousal abuse, especially those who have
3	orders of protection;
4	(3) Help develop a Spousal Abuse Safety Plan publication to help
5	victims by:
6	(A) Making the publication available in public health
7	centers; and
8	(B) Allowing police officers to distribute the publication
9	to victims when responding to spousal abuse call;
10	(4) Create special training initiatives regarding the dynamics
11	of spousal abuse for police intake officers, health officials, and social

14	(5) Encourage the development of community-based, civic-based
15	and faith-based healthy relationship courses to teach:
