21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 *SECTION 1. Arkansas Code § 2-20-804(a)(1), concerning the creation of*
24 *the Arkansas Corn and Grain Sorghum Promotion Board, is amended to read as*
25 *follows:*

26 *(a)(1) The Arkansas Corn and Grain Sorghum Promotion Board is created*
27 *~~and domiciled in Little Rock, Arkansas, 10720 Kanis Road within the Arkansas~~*
28 *Agriculture Department, and is composed of seven (7) producer members*
29 *appointed by the Governor as provided in this subsection.*

30
31 *SECTION 2. Arkansas Code § 2-20-805(c)(2), concerning disbursements of*
32 *assessments by the Arkansas Corn and Grain Sorghum Promotion Board, is*
33 *amended to read as follows:*

34 *(2)(A)(i) The proceeds of the assessment, ~~less not more than~~*
35 *~~three percent (3%) to cover the cost of collections,~~ shall be deposited with*
36 *the Treasurer of State in a special fund to be established for the board to*

1 *the credit of the ~~board~~ Arkansas Corn and Grain Sorghum Promotion Board.*

2 *(ii) The Director of the Department of Finance and*
3 *Administration may deduct not more than three percent (3%) to cover the cost*
4 *of collections.*

5 *(iii) The Treasurer of State shall direct two*
6 *percent (2%) of the revenues collected beginning on and after July 1, 2012,*
7 *into the Arkansas Agriculture Department Fund Account to be used exclusively*
8 *for operation and administration expenses related to the Arkansas Corn and*
9 *Grain Sorghum Promotion Board.*

10 *(B) Disbursement from the special fund shall be made only*
11 *upon a motion duly passed by the board and presented to the Treasurer of*
12 *State and only for a purpose prescribed in this subchapter.*

13
14 *SECTION 3. DO NOT CODIFY. This act becomes effective on July 1, 2012.*
