18	AN ACT TO CREATE THE DEVELOPMENTAL
19	DISABILITIES COUNCIL.
20	
21	
22	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
23	
24	SECTION 1. Arkansas Code §§ 20-8-111 and 20-8-112 are repealed.
25	20-8-111. Transfer of Developmental Disabilities Planning Council
26	attributes to other agency.
27	The Governor may at any time transfer all personnel, appropriations,
28	fund balances, and authorized positions, and the powers, duties, and
29	personnel of the Developmental Disabilities Planning Council to any other
30	designated agency of the state which meets the requirements of Pub. L. No.
31	101-496 [repealed].
32	
33	20-8-112. Additional transfer of Developmental Disabilities Planning
34	Council attributes to other agency.
35	The Governor may at any time transfer all the powers, duties,
36	personnel, appropriations, fund balances, and authorized positions of the

1	Developmental Disabilities Planning Council to any other designated agency of
2	the state which meets the requirements of Pub. L. No. 103-230.
3	
4	SECTION 2. Arkansas Code Title 25 is amended to add an additional
5	chapter to read as follows:
6	<u>Chapter 42 - Developmental Disabilities Council</u>
7	
8	25-42-101. Purpose.
9	The purpose of this chapter is to coordinate, monitor, plan, and
10	evaluate services, assistance, and opportunities necessary to enable
11	individuals with developmental disabilities to achieve their maximum
12	potential through:
13	(1) Increased self-determination, independence, productivity,
14	and integration and inclusion into the community; and
15	(2) Enhancement of the role of the family in assisting
16	individuals with developmental disabilities.
17	
18	25-42-102. Definitions.
19	As used in this chapter:
20	(1) "Developmental disability" means:
21	(A) A severe, chronic disability of an individual that:
22	(i) Is attributable to a mental or physical
23	impairment or combination of mental and physical impairments;
24	(ii) Is manifested before the individual becomes
25	twenty-two (22) years of age;
26	(iii) Is likely to continue indefinitely;
27	(iv) Results in substantial functional limitations
28	in three (3) or more of the following areas of major life activity:
29	(a) Self-care;
30	(b) Receptive and expressive language;
31	(c) Learning;
32	(d) Mobility;
33	(e) Self-direction;
34	(f) Capacity for independent living; or
35	(g) Economic sufficiency; and
36	(v) Reflects the individual's need for a combination

1	and sequence of special, interdisciplinary, or generic care, treatment, or
2	other services that are of lifelong or extended duration and are individually
3	planned and coordinated; and
4	(B) A substantial developmental delay or specific
5	congenital or acquired condition in an individual from birth to nine (9)
6	years of age that without services and support has a high probability of
7	resulting later in life in three (3) or more of the criteria listed in
8	subdivision (1)(A) of this section;
9	(2)(A) "Family support" means services designed to:
10	(i) Strengthen the family's role as primary
11	<pre>caregivers;</pre>
12	(ii) Prevent inappropriate out-of-home placement and
13	maintain family unity; and
14	(iii) Reunite families with members who have been
15	placed out of the home.
16	(B) "Family support" includes:
17	(i) Respite care;
18	(ii) Personal care;
19	(iii) Parent training and counseling;
20	(iv) Support for elderly parents; and
21	(v) Other individualized services;
22	(3) "Inclusion" means the acceptance and encouragement of the
23	presence and participation of individuals with developmental disabilities, by
24	individuals without disabilities in social, educational, work, and community
25	activities, which enable an individual with developmental disabilities to:
26	(A) Have friendships and relationships with individuals
27	and families of his or her own choice;
28	(B) Live in a home close to community resources, with
29	regular contact with individuals without disabilities in his or her
30	<pre>community;</pre>
31	(C) Enjoy full access to and active participation in the
32	same community activities and types of employment as individuals without
33	disabilities; and
34	(D) Take full advantage of his or her integration into the
35	same community resources as individuals without disabilities by living,
36	learning, working, and enjoying life in regular contact with individuals

1	without disabilities;
2	(4) "Independence" means the extent to which an individual with
3	developmental disabilities exerts control and choice over his or her own
4	<pre>life;</pre>
5	(5) "Integration" means exercising the equal right of
6	individuals with developmental disabilities to access and use the same
7	community resources as are used by and available to other individuals;
8	(6) "Productivity" means:
9	(A) Engagement in income-producing work by an individual
10	with developmental disabilities that is measured through improvements in
11	income level, employment status, or job advancement; and
12	(B) Engagement by an individual with developmental
13	disabilities in work that contributes to a household or community;
14	(7) "Self-determination activities" means activities that with
15	appropriate assistance result in an individual with developmental
16	disabilities having:
17	(A) The ability and opportunity to communicate and make
18	personal decisions;
19	(B) The ability and opportunity to communicate choices and
20	exercise control over the type and intensity of services, support, and other
21	assistance the individual receives;
22	(C) The authority to control resources to obtain needed
23	services, support, and other assistance;
24	(D) Opportunities to participate in and contribute to his
25	or her community; and
26	(E) Support, including financial support, to advocate for
27	himself or herself and others, to develop leadership skills through training
28	in self-advocacy, to participate in coalitions, to educate policymakers, and
29	to play a role in the development of public policies that affect individuals
30	with developmental disabilities.
31	
32	25-42-103. Developmental Disabilities Council — Creation — Membership.
33	(a) The Developmental Disabilities Council is created.
34	(b)(1) Under the Developmental Disabilities Assistance and Bill of
35	Rights Act of 2000, Pub. L. No. 106-402, the council's membership shall
36	consist of not less than sixty percent (60%) of individuals with

1	developmental disabilities, parents or guardians of children with
2	developmental disabilities. or immediate relatives or guardians of adults
3	with mentally impairing developmental disabilities who cannot advocate for
4	themselves.
5	(2) Members of the council shall not be employees of a state
6	agency that receives funds or provides services under the Developmental
7	Disabilities Assistance and Bill of Rights Act of 2000, Pub. L. No. 106-402.
8	(c)(1) The members of the council shall serve four-year terms, except
9	$\underline{\text{that the initial appointees shall serve staggered terms}} \ \ \underline{\text{determined by lot so}}$
10	that five (5) serve a two-year term, five (5) serve a three-year term, and
11	five (5) serve a four-year term.
12	(2) Members of the council shall not serve more than two (2)
13	consecutive four-year terms.
14	(d)(1) The members of the council shall serve without compensation.
15	(2) However, the members of the council may receive expense
16	reimbursement and stipends under § 25-16-902.
17	
18	25-42-104. Duties.
19	The Developmental Disabilities Council shall:
20	(1) Plan effective coordination of state resources to meet the
21	needs of individuals with developmental disabilities;
22	(2) Promote the dignity of individuals with developmental
23	disabilities;
24	(3) Advise the Governor and the General Assembly on programs and
25	policies pertaining to services for individuals with developmental
26	disabilities and their families;
27	(4) Promote the provision of a full range of services,
28	assistance, and opportunities for individuals with developmental
29	disabilities, including housing, education, rehabilitation, employment,
30	recreation, family support, and other needed support services, in the least
31	restrictive environment;
32	(5) Assist public and private entities in creating programs that
33	increase the potential of an individual with disabilities to expand his or
34	her inclusion, productivity, and self-determination activities;
35	(6) Assist in the development of state plans to include the
36	establishment of goals and priorities for meeting the needs of individuals

T	with developmental disabilities;
2	(7) Review programs and policies that affect individuals with
3	developmental disabilities, identify gaps and barriers to services, and
4	assist in prevention of duplicative programs and services;
5	(8) Promote public understanding of the needs and contributions
6	of individuals with developmental disabilities;
7	(9) Develop, maintain, and disseminate information models,
8	findings, conclusions, and recommendations to enhance assistance and
9	opportunities for individuals with developmental disabilities;
10	(10) Monitor the provision of services to individuals with
11	developmental disabilities;
12	(11) Prepare, approve, and implement a budget using amounts paid
13	to the state under the Developmental Disabilities Assistance and Bill of
14	Rights Act of 2000, Pub. L. No. 106-402;
15	(12) Fund and implement all programs, projects, and activities
16	carried out under the Developmental Disabilities Assistance and Bill of
17	Rights Act of 2000, Pub. L. No. 106-402;
18	(13) Enhance coordination among public and private agencies by
19	conducting studies and developing model policies and procedures; and
20	(14) Administer the provisions of the Developmental Disabilities
21	Act, Pub. L. No. 106-402, regarding state councils on disabilities.
22	
23	25-42-105. Executive director — Staff.
24	(a) The Developmental Disabilities Council shall recruit and hire an
25	individual consistent with state law to serve as Executive Director of the
26	Developmental Disabilities Council who shall be the chief operating officer
27	of the council and whose duties shall be designated by the council.
28	(b) The council may hire and maintain such members and types of staff
29	qualified by training and experience and obtain the services of such
30	professional, consulting, technical, and clerical staff consistent with state
31	law as the council determines to be necessary to carry out the functions of
32	the council.
33	(c) The executive director and other personnel employed by the council
34	shall be employees of the State of Arkansas.

25-42-106. Reports.

1	The Developmental Disabilities Council shall report annually to the
2	Governor and the House Committee on Public Health, Welfare, and Labor and the
3	Senate Committee on Public Health, Welfare, and Labor on the progress of
4	programs for individuals with developmental disabilities.
5	
6	25-42-107. Rules.
7	The Developmental Disabilities Council may adopt rules to implement
8	this chapter.
