21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code § 23-115-103(12)(A) and (B), concerning the
24	definition of "lottery" under the Arkansas Scholarship Lottery Act, are
25	amended to read as follows:
26	(12)(A) "Lottery" means a game of chance approved by the
27	Arkansas Lottery Commission and operated under this chapter.
28	(B) "Lottery" includes without limitation:
29	(i) An instant ticket;
30	(ii) A draw game;
31	(iii) Participation in a multistate or
32	multisovereign game; and
33	(iv) A raffle <u>; and</u>
34	(v) A prize-linked savings account program.

1	SECTION 2. Arkansas Code § 23-115-103(13), concerning the definition
2	of "lottery proceeds" under the Arkansas Scholarship Lottery Act, is amended
3	to read as follows:
4	(13) "Lottery proceeds" means all <u>:</u>
5	(A) revenue Revenue derived from the sale of tickets or
6	shares; and
7	(B) all other Other moneys derived from or in connection
8	with the operation of a lottery, including without limitation:
9	(i) fees Fees, offsets, reimbursements, insurance
10	proceeds, damages, and liquidated damages collected or imposed by the
11	Arkansas Lottery Commission under this chapter; and
12	(ii) Interest credited to the Arkansas Lottery
13	Commission under a prize-linked savings account program;
14	
15	SECTION 3. Arkansas Code Title 23, Chapter 115, Subchapter 4 is
16	amended to add an additional section to read as follows:
17	23-115-411. Prize-linked savings account program.
18	(a) As used in this section:
19	(1) "Minimum savings account deposit" means an amount of not
20	less than twenty-five dollars (\$25.00) that the Arkansas Lottery Commission
21	deposits on behalf of a patron into a prize-linked savings account;
22	(2) "Patron" means an individual:
23	<u>(A) Who validly purchases a ticket in a prize-linked</u>
24	savings account program; and
25	(B) On whose behalf funds are deposited into a prize-
26	<u>linked savings account;</u>
27	(3) "Prize-linked savings account" means a savings account,
28	certificate of deposit, or other interest-bearing savings program at a
29	financial institution:
30	(A) Into which deposits are made from the prize-linked
31	savings account program operated by the commission;
32	(B) In which the deposits are held in trust on behalf of
33	each individual patron; and
34	(C) From which the interest earned is paid to the
35	commission for the operation of the prize-linked savings account program; and

1	(4) "Savings ticket" is a ticket or share validly purchased by a
2	player in a prize-linked savings account program.
3	(b) The commission may establish a prize-linked savings account
4	program through a lottery game that:
5	(1) Is designed and marketed specifically for the prize-linked
6	savings account program;
7	(2) Awards to patrons monthly prizes and annual prizes;
8	(3) Provides an opportunity for a player to become a patron by
9	purchasing a savings ticket and registering that ticket with the commission;
10	and
11	(4) Provides that the commission shall deposit the value of a
12	registered savings ticket into a prize-linked savings account on behalf of a
13	patron.
14	<u>(c)(1) A patron at any time may withdraw funds on deposit for the</u>
15	patron in a prize-linked savings account, but the withdrawal may affect the
16	patron's eligibility for receiving a prize from the program.
17	(2) The program may provide incentives for patrons to:
18	(A) Retain the funds in the prize-linked savings account;
19	and
20	(B) Deposit cash winnings from the program into the prize-
21	linked savings account.
22	(d) A prize-linked savings account shall bear interest at a rate that
23	is equal to the interest paid by the depository institution for a comparable
24	savings account, certificate of deposit, or other savings program offered at
25	the depository institution.
26	(e) This program does not waive the provisions of § 23-115-
27	207(a)(2)(B) requiring the sales of tickets or shares for cash only.
