21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23	SECTION 1. Arkansas Code Title 6, Chapter 15, Subchapter 13, is
24	amended to add an additional section to read as follows:
25	6-15-1303. Confidential information.
26	(a) Records or information that have been adopted by a school, a
27	school district, or the State Board of Education and that indicate a policy,
28	procedure, or plan to ensure school security or a safe learning environment
29	for students and school employees shall be treated as confidential and are
30	exempt from public disclosure under the Freedom of Information Act of 1967, §
31	<u>25-19-101 et seq.</u>
32	(b) Meetings or consultations of a school, school district board of
33	directors, or the State Board of Education for the purpose of developing or
34	instituting a policy, procedure, or plan to ensure school security or a safe
35	learning environment for students and school employees shall be treated as

12	(a) Records or information that have been adopted by a state-supported
13	institution of postsecondary or higher education and that indicate a policy,
14	procedure, or plan to ensure campus security or a safe learning environment
15	for students and school employees shall be treated as confidential and are
16	exempt from public disclosure under the Freedom of Information Act of 1967, §
17	<u>25-19-101 et seq.</u>
18	(b) Meetings or consultations of a state-supported institution of
19	postsecondary or higher education for the purpose of developing or
20	instituting a policy, procedure, or plan to ensure campus security or a safe
21	learning environment for students and school employees shall be treated as
22	confidential and are exempt from public disclosure under the Freedom of
23	Information Act of 1967, § 25-19-101 et seq.
24	(c) Nothing in this section shall be construed to exempt from
25	disclosure policies or procedures adopted by a school or school district
26	regarding student or employee standards of conduct, including student
27	discipline policies and employee personnel policies.
