23	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

25	SECTION 1. Arkansas Code § 17-19-108 is amended to read as follows:
26	17-19-108. Rules <del>and regulations</del> .
27	The Professional Bail Bond Company and Professional Bail Bondsman
28	Licensing Board shall adopt <del>such</del> reasonable rules <del>and regulations</del> as it <del>shall</del>
29	deem deems necessary to assure the effective and efficient administration of
30	§§ $17-19-107$ and $17-19-212$ and § $17-19-401$ et seq.
31	
32	SECTION 2. Arkansas Code § 17-19-110 is amended to read as follows:
33	17-19-110. Licensed bail bond agent.
34	(a)(1) A person may apply for one (1) of the following licenses under
35	this chapter:
36	(A) A class 1 bail bond agent license; or

1	(B) A class 2 bail bond agent license.
2	(2)(A) A class 1 bail bond agent license permits a licensee to
3	write bonds under this chapter, but the licensee may not engage in the
4	apprehension of a defendant who has failed to appear in court as required by
5	the term of his or her bond.
6	(B) A class 2 bail bond agent license permits a licensee
7	to write bonds under this chapter as well as apprehend a defendant who has
8	failed to appear in court as required by the terms of his or her bond.
9	(a)(b) A licensed bail bond agent shall be permitted to write a bail
10	bond in any county if:
11	(1) The agent has a current license with a current licensed
12	professional bail bond company; and
13	(2) The agent and the agent's company are in good standing with
14	the courts in the jurisdiction where the bond is to be posted.
15	(b)(c) A licensed bail bond agent shall carry a current copy of his or
16	her professional bail bond agent license that shall indicate which
17	professional bail bond company the <del>bondsman</del> <u>agent</u> works for and his or her
18	qualifying power of attorney that is on file with the Professional Bail Bond
19	Company and Professional Bail Bondsman Licensing Board.
20	$\frac{(c)(1)}{(d)(1)}$ Only one (1) power of attorney per bond not exceeding the
21	agent's qualifying power of attorney shall be permitted unless a court has
22	separated the charges and amounts of bonds.
23	(2) Powers of attorney shall not be stacked.
24	
25	SECTION 3. Arkansas Code § 17-19-212 is amended to read as follows:
26	17-19-212. Licenses.
27	(a) Each An applicant for an initial bail bondsman a class 1 bail bond
28	$\underline{\text{agent}}$ license $\underline{\text{who}}$ $\underline{\text{shall}}$ satisfactorily $\underline{\text{completes}}$ $\underline{\text{complete}}$ the examination and
29	meets meet the other qualifications and requirements prescribed by law,
30	including the completion of a minimum of eight (8) hours of education in
31	subjects pertaining to the authority and responsibilities of a <del>bail bondsman</del>
32	<u>licensed bail bond agent</u> and a review of the laws and <del>regulations relating</del>
33	thereto, shall be licensed by the Professional Bail Bond Company and
34	Professional Bail Bondsman Licensing Board rules.
35	(b) An applicant for a class 2 bail bond agent license shall satisfy
36	the requirements for a class 1 bail bond agent license as well as complete

1	one hundred (100) hours of in-classroom instruction and training, including
2	without limitation the following topics:
3	(1) Fourth Amendment search and seizure;
4	(2) Use of force;
5	(3) Lawful entry into a residence; and
6	(4) Firearms qualification.
