20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. Arkansas Code § 5-36-103(b)(3)(A), concerning the amount of
23 money that constitutes theft of property that is a Class D felony, is amended
24 to read as follows:

25 (A) The value of the property is five thousand dollars
26 (\$5,000) or less but more than ~~one thousand dollars (\$1,000)~~ five hundred
27 dollars (\$500);

29 SECTION 2. Arkansas Code § 5-36-103(b)(4)(A), concerning the amount of
30 money that constitutes misdemeanor theft of property, is amended to read as
31 follows:

32 (A) The value of the property is ~~one thousand dollars~~
33 ~~(\$1,000)~~ five hundred dollars (\$500) or less; or

1 SECTION 3. Arkansas Code § 5-36-104(c)(3), concerning the amount of
2 money that constitutes theft of services that is a Class D felony, is amended
3 to read as follows:

4 (3) Class D felony if the value of the service is five thousand
5 dollars (\$5,000) or less but more than ~~one thousand dollars (\$1,000)~~ five
6 hundred dollars (\$500); or

8 SECTION 4. Arkansas Code § 5-36-105(b), concerning the amount of money
9 that constitutes theft of property that is lost, mislaid, or delivered by
10 mistaken that is a Class D felony, is amended to read as follows:

11 (b) Theft of property lost, mislaid, or delivered by mistake is a:

12 (1) Class D felony if the value of the property is ~~one thousand~~
13 ~~dollars (\$1,000)~~ five hundred dollars (\$500) or more; or

14 (2) Class B misdemeanor if:

15 (A) The value of the property is less than ~~one thousand~~
16 ~~dollars (\$1,000)~~ but more than five hundred dollars (\$500); or

17 (B) The property is a:

18 (i) Credit card or credit card account number; or

19 (ii) Debit card or debit card account number; ~~or.~~

20 ~~(3) Class C misdemeanor if otherwise committed.~~
21

22 SECTION 5. Arkansas Code § 5-36-106(e)(3)(A), concerning the amount of
23 money that constitutes theft by receiving that is a Class D felony, is
24 amended to read as follows:

25 (A) The value of the property is five thousand dollars
26 (\$5,000) or less but more than ~~one thousand dollars (\$1,000)~~ five hundred
27 dollars (\$500);
