20	TO AMEND THE DISTRIBUTION OF REVENUES
21	DERIVED FROM THE ADDITIONAL TAX LEVIED ON
22	DEEDS, INSTRUMENTS, AND WRITINGS; AND TO
23	PROVIDE FUNDING FOR THE ARKANSAS HOUSING
24	TRUST FUND.

27	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
28	
29	SECTION 1. Arkansas Code § 15-12-103(b)(1)(A), concerning the
30	distribution of revenues derived from the additional tax levied on deeds,
31	instruments, and writings, is amended to read as follows:
32	(b) After deducting three percent (3%) of the revenues for
33	distribution to the Constitutional Officers Fund and the State Central
34	Services Fund to be used for the purposes as provided by law, the Treasurer
35	of State shall credit the net amount thereof of the revenues as follows:

1	(1)(A) Eighty percent (80%) Sixty percent (60%) of the net
2	amount shall be credited to the Arkansas Natural and Cultural Resources
3	Grants and Trust Fund, to be preserved and managed by the Arkansas Natural
4	and Cultural Resources Council for use in the acquisition, management, and
5	stewardship of state-owned lands or the preservation of state-owned historic
6	sites, buildings, structures, or objects which that the council determines to
7	be of value for recreation or conservation purposes, with the properties to
8	be used, preserved, and conserved for the benefit of this and future
9	generations.
10	
11	SECTION 2. Arkansas Code § 15-12-103(b), concerning the distribution
12	of revenues derived from the additional tax levied on deeds, instruments, and
13	writings, is amended to add an additional subdivision to read as follows:
14	(4) Twenty percent (20%) of the net amount shall be credited to
15	the Arkansas Housing Trust Fund to be used as follows:
16	(A) Ninety percent (90%) of the funds may be used for any
17	purpose stated in § 15-5-1708; and
18	(B)(i) Ten percent (10%) of the funds may be used for the
19	purpose of providing adequate, safe, and affordable housing for veterans.
20	(ii) However, any funds designated under subdivision
21	(b)(4)(B)(i) of this section that have not been used as provided under
22	subdivision (b)(4)(B)(i) of this section by the end of each fiscal year may
23	be used for any purpose stated in § 15-5-1708.
