16	TO ESTABLISH CANCER PATIENT NAVIGATION TO
17	IMPROVE THE CARE OF CANCER PATIENTS IN
18	THIS STATE.
19

21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Arkansas Code Title 20, Chapter 15, Subchapter 2, is
24	amended to add an additional section to read as follows:
25	20-15-206. Cancer patient navigation.
26	(a) As used in this section:
27	(1) "Health disparity population" means a population that has
28	significant disparity in the rate of cancer incidence, prevalence, morbidity,
29	or survival rates as compared to the general population; and
30	(2) "Patient navigation" means the facilitating the care of
31	patients through:
32	(A) Acting as contacts for individuals who are found to
33	have a symptom, abnormal finding, or diagnosis of cancer following a
34	screening or early detection service, including without limitation the
35	assistance in the coordination of healthcare services and healthcare provider
36	<u>referrals;</u>

1	(B) Facilitating the involvement of community
2	organizations in assisting individuals who are at risk for or who have cancer
3	by creating partnerships with patient advocacy groups, charities, healthcare
4	centers, community hospice centers, healthcare providers, or other
5	organizations in the targeted community;
6	(C) Notifying individuals of clinical trials and if
7	requested, facilitating enrollment in the clinical trials;
8	(D) Anticipating, identifying, and helping patients
9	overcome barriers within the healthcare system to ensure prompt diagnostic
10	and treatment resolution of an abnormal finding of cancer;
11	(E) Coordinating with a relevant health insurance
12	ombudsman program to provide information to individuals who are at risk for
13	or who have cancer about health coverage, including without limitation
14	private insurance, healthcare savings accounts, the Arkansas Medicaid
15	Program, and other publicly funded programs; and
16	(F) Conducting ongoing outreach to health disparity
17	populations.
18	(b) The Winthrop P. Rockefeller Cancer Institute at the University of
19	Arkansas for Medical Sciences may establish a comprehensive cancer patient
20	navigation program to:
21	(1) Guide patients who are diagnosed with cancer through the
22	healthcare system;
23	(2) Help patients who are diagnosed with cancer overcome
24	physical, emotional, social, and financial barriers to receiving timely and
25	efficient cancer treatment; and
26	(3) Improve care of patients who are diagnosed with cancer in
27	this state.
