20	TO CREATE A TWO-YEAR LICENSE OPTION; AND	
21	TO REQUIRE FOUR HOURS OF CONTINUING	
22	EDUCATION PER YEAR OF THE TERM OF THE	
23	LICENSE, TO INCLUDE PERSONAL SAFETY,	
24	CURRENT MARKETING TRENDS, AND REAL ESTATE

28	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:	
29		
30	SECTION 1. Arkansas Code § 17-42-307(a) and (b), concerning the	
31	expiration and renewal of a license issued by the Arkansas Real Estate	
32	Commission, are amended to read as follows:	
33	(a)(1) Every license shall expire on a date established by the	
34	Arkansas Real Estate Commission.	
35	(2) The commission shall offer a broker or salesperson the	
36	option of either:	

1	(A) A license valid for one (1) year with a minimum
2	requirement of four (4) continuing education hours; or
3	(B) A license valid for two (2) years with a minimum
4	requirement of eight (8) continuing education hours.
5	(b)(1) A broker or salesperson shall complete annually:
6	(A) Not less than six (6) or more than seven (7) Four (4)
7	classroom hours of continuing education required by the commission <u>for each</u>
8	year of licensure with a minimum of at least one (1) classroom hour focusing
9	on each of the following areas of education:
10	(1) personal Personal safety precautions for real
11	estate agents;
12	(2) Current real estate marketing and advertising
13	trends and compliance with state rules and federal regulations;
14	(3) Updates to contracts and other real estate
15	forms, current law, rules, and compliance in the real estate industry; and
16	(4) Any other relevant real estate education
17	approved by the commission;
18	(B) The distance education equivalent of subdivision
19	(b)(l)(A) of this section required by the commission; or
20	(C) A course that the commission has determined to
21	demonstrate mastery of an acceptable real estate subject.
22	(2) $\underline{(A)}$ A licensee who satisfies subdivision (b)(1) of this
23	section completes the continuing education requirements for the licensing
24	year <u>or years.</u>
25	(B) A licensee applying for a license valid for two (2)
26	years may complete all eight (8) required hours of continuing education at
27	any time over a two-year period.
28	(3) If a licensee files for renewal of a license but fails to
29	provide proof of continuing education, the licensee's license is will become
30	inactive until proof is provided to the commission.
31	(4) Effective September 30, 2019, the commission may promulgate
32	rules to add additional hours of continuing education to the annual amount
33	required under subdivision (b)(1)(Λ) of this section with no statutory
34	maximum for hours of continuing education A licensee applying for a license
35	valid for two (2) years shall pay the annual license renewal fee for both
36	vears of the license.

3	SECTION 2. Arkansas Code § 17-42-307(f)(2), concerning the expiration
4	and renewal of a license issued by the Arkansas Real Estate Commission, is
5	amended to read as follows:
6	(2) If the licensee fails to complete the post-licensure
7	education requirements within twelve (12) months the twelve-month period
8	after the date the license was issued, the commission shall place the license
9	on inactive status until the commission receives documentation that the
10	licensee has completed the post-licensure education requirements.
