15	TO CREATE THE CHILD MALTREATMENT
16	INVESTIGATION BODY CAMERA PILOT PROGRAM.

19	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20	
21	SECTION 1. Arkansas Code Title 12, Chapter 18, is amended to add an
22	additional subchapter to read as follows:
23	<u>Subchapter 13 — Child Maltreatment Investigation Body Camera Pilot Program</u>
24	
25	12-18-1301. Title.
26	This subchapter shall be known and may be cited as the "Child
27	Maltreatment Investigation Body Camera Pilot Program".
28	
29	12-18-1302. Legislative intent.
30	It is the intent of the General Assembly that this subchapter:
31	(1) Reduce the number of complaints and allegations made against
32	employees of the child welfare system in this state; (2) Assist in execting experturities for the improved training
33 34	(2) Assist in creating opportunities for the improved training and skill enhancement of each person who is assigned to investigate child
35	maltreatment or suspected child maltreatment and of other employees of the
36	child welfare system;

1	(3) Increase transparency in the investigation of child
2	maltreatment or suspected child maltreatment; and
3	(4) Improve public confidence and trust in the child welfare
4	system operations of this state.

6	12-18-1303. Child Maltreatment Investigation Body Camera Pilot
7	Program.
8	(a) There is created a program to be known as the "Child Maltreatment
9	Investigation Body Camera Pilot Program".
10	(b) The program shall be developed, implemented, and administered by
11	the Department of Human Services in collaboration with the Department of
12	Arkansas State Police.
13	(c) The Department of Human Services and the Department of Arkansas
14	State Police shall:
15	(1) Work cooperatively to establish criteria and recommendations
16	for the use of a body camera by an investigator during the investigation of
17	child maltreatment or suspected child maltreatment; and
18	(2) Require no more than ten (10) investigators to each use a
19	body camera during his or her interview of a person required to be
20	interviewed as part of an investigation of child maltreatment or suspected
21	child maltreatment in § 12-18-605.
22	
23	12-18-1304. Funding
24	(a) The Department of Human Services and the Department of Arkansas
25	State Police shall:
26	(1) Cooperatively work to fund the implementation of the Child
27	Maltreatment Investigation Body Camera Pilot Program; and
28	(2) Execute a memorandum of understanding to delineate each
29	department's participation, obligation, and cooperation in providing funds
30	for the implementation of the program.
31	(b) The General Assembly recognizes that the agreement under
32	subsection (a) of this section is not:
33	(1) A mandate by the General Assembly; or
34	(2) An appropriation of funds by the General Assembly.

1	SECTION 2. DO NOT CODIFY. Child Maltreatment Investigation Body Camera
2	<u>Pilot Program - Reporting.</u>
3	By December 31, 2020, the Department of Human Services and the
4	Department of Arkansas State Police shall submit a joint report on whether or
5	not the Child Maltreatment Investigation Body Camera Pilot Program has been
6	successful and the requirements necessary to continue the use of a body
7	camera by each investigator of child maltreatment or suspected child
8	<pre>maltreatment:</pre>
9	(1) Senate Interim Committee on Children and Youth; and
10	(2) House Committee on Aging, Children and Youth, Legislative
11	and Military Affairs.
