3	REQUESTING THE LEGISLATIVE COUNCIL REFER TO THE HOUSE COMMITTEE
4	ON AGING, CHILDREN AND YOUTH, LEGISLATIVE AND MILITARY AFFAIRS A
5	STUDY REGARDING CONSUMER PROTECTION OF SENIOR CITIZENS FROM
6	PREDATORY PRACTICES; AND SAFEGUARDING AGAINST FINANCIAL
7	EXPLOITATION OF RETIREES FOR ARKANSANS.

9	WHEREAS, protecting elderly adults and vulnerable adults is a priority
10	for the State of Arkansas; and
11	
12	WHEREAS, the number of cases involving scams or exploitation of elderly
13	adults or vulnerable adults has quadrupled in the last three (3) years, yet
14	elderly adults or vulnerable adults are the least likely of any age or
15	socioeconomic group to report losing money to fraud; and
16	
17	WHEREAS, elderly adults are using wire transfers and other types of
18	electronic payment methods to send money to fraudulent people who are
19	perpetuating romance scams, government imposter scams, and sweepstakes scams
20	and
21	
22	WHEREAS, the economic effects of romance scams, government imposter
23	scams, and sweepstakes scams can be devastating to elderly adults or
24	vulnerable adults, and
25	
26	NOW THEREFORE,
27	BE IT PROPOSED BY THE LEGISLATIVE COUNCIL OF THE NINETY-THIRD GENERAL
28	ASSEMBLY OF THE STATE OF ARKANSAS:
29	
30	THAT the Legislative Council refer to the House Committee on Aging,
31	Children and Youth, Legislative and Military Affairs a study to:
32	(1) Determine the best practices required to protect elderly
33	adults and vulnerable adults from deceptive acts or practices in commerce;
34	and
35	(2) Determine the best practices to provide the financial
36	institutions in this state, as well as the Attorney General and other law
