24	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25	
26	SECTION 1. Arkansas Code Title 11, Chapter 4, Subchapter 4, is amended
27	to add an additional section to read as follows:
28	11-4-406. Recoupment of overpayment of wages.
29	(a) In order to recoup an overpayment of wages paid to an employee, an
30	<pre>employer shall:</pre>
31	(1) Provide written notice to an employee at least twenty-one
32	(21) days in advance before first deducting from the employee's wages; and
33	(2) Deduct no more than twenty percent (20%) of the employee's
34	gross wages per pay period to recoup the overpayment.
35	(b) The advance written notice required under subdivision (a)(1) of
36	this section shall specify the.

1	(1) Amount of overpayment to be recouped;
2	(2) Method used to calculate the overpayment; and
3	(3) Cause of the overpayment.
4	(c) An employer that violates this section shall:
5	(1) Return to the employee any deductions made from the
6	employee's paychecks; and
7	(2) Pay the employee an additional amount equal to the improper
8	deductions taken from the employee's wages as liquidated damages.
9	(d) Subsections (a)-(c) of this section do not apply to the recoupment
10	of an overpayment of wages by an employer when the overpayment of wages:
11	(1) Is discovered after only one (1) pay period; or
12	(2) Has been paid to an employee who is employed in a grant-
13	funded position.
