21	TO AUTHORIZE THE ARKANSAS STATE GAME AND
22	FISH COMMISSION TO PROMULGATE RULES
23	ALLOWING FEE ADJUSTMENT TO RESIDENT
24	HUNTING AND FISHING LICENSES BASED ON
25	CERTAIN CRITERIA; AND TO REQUIRE
26	REPORTING.

29	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
30	
31	SECTION 1. Arkansas Code § 15-42-104(e), concerning special fees for
32	hunting and fishing licenses for residents, is amended to read as follows:
33	(e) For this section, the commission may promulgate rules that:
34	(1) Define "resident" and "totally disabled"; and
35	(2) Govern the sale and use of each license, permit, or stamp
36	issued under this section.; and

1	(3)(A) Allow adjustment for an increase or decrease in the
2	amount of the maximum fee, also known as the "baseline maximum", for each
3	resident license, permit, or stamp set forth in subsections (a)-(d) of this
4	section in accordance with the following:
5	(i) Beginning July 1, 2021, each adjusted maximum
6	fee, also known as the "adjusted maximum", shall not exceed sixty-five
7	percent (65%) of the present value of the baseline maximum, as calculated
8	using the Consumer Price Index;
9	(ii) From July 1, 2026, until June 30, 2031, each
10	adjusted maximum may be increased by up to twenty-five percent (25%) of the
11	adjusted maximum previously determined under subdivision (e)(3)(A)(i) of this
12	section; and
13	(iii) On or after July 1, 2031, each adjusted
14	maximum may be increased by up to twenty-five percent (25%) of the adjusted
15	maximum amount previously determined under subdivision (e)(3)(A)(ii) of this
16	section.
17	(B) The commission shall provide a semiannual report to
18	the Game and Fish/State Police Subcommittee of the Legislative Council for
19	administrative review of the total amount of increased fees for resident
20	licenses, permits, or stamps collected as a result of the fee adjustments
21	under subdivision (e)(3)(A) of this section.
22	(f) As used in this section:
23	(1) "Consumer Price Index" means the Consumer Price Index for
24	All Urban Consumers (CPI-U), U.S. City Average, all items, not seasonally
25	adjusted, 1982-1984 equals 100 reference base, as published by the United
26	States Bureau of Labor Statistics; and
27	(2) "Present value" means an amount calculated by multiplying
28	the baseline maximum by a fraction whose numerator is the Consumer Price
29	Index for the month of the proposed adjustment and whose denominator is the
30	Consumer Price Index for the month when the baseline maximum was established
31	or last adjusted.
