15	CONCERNING THE POSSESSION OF MARIJUANA.

18	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
19	
20	SECTION 1. Arkansas Code § 5-64-419(b)(5), concerning the possession
21	of a Schedule VI controlled substance, is amended to read as follows:
22	(5) A Schedule VI controlled substance with an aggregate weight,
23	including an adulterant or diluent, of:
24	(A) <u>(i)</u> Less than four ounces (4 oz.) upon conviction is
25	guilty of a Class A misdemeanor <u>.</u>
26	(ii) However, if the Schedule VI controlled
27	substance is marijuana with an aggregate weight, including an adulterant or
28	diluent, of less than one ounce (1 oz.), the offense is a violation with a
29	<pre>maximum fine of two hundred dollars (\$200);</pre>
30	(B) <u>(i)</u> One ounce (1 oz.) or more but less than four ounces
31	(4 oz.) and the person has four (4) previous convictions under this section
32	or the former § 5-64-401(c) upon conviction is guilty of a Class D felony ; .
33	(ii) However, a conviction under subdivision
34	(b)(5)(A)(ii) of this section is not a previous conviction under subdivision
35	(b)(5)(B)(i) of this section;

1	(C) Four ounces (4 oz.) or more but less than ten pounds
2	(10 lbs.) upon conviction is guilty of a Class D felony;
3	(D) Ten pounds (10 lbs.) or more but less than twenty-five
4	pounds (25 lbs.) upon conviction is guilty of a Class C felony;
5	(E) Twenty-five pounds (25 lbs.) or more but less than one
6	hundred pounds (100 lbs.) upon conviction is guilty of a Class B felony; or
7	(F) One hundred pounds (100 lbs.) or more but less than
8	five hundred pounds (500 lbs.) upon conviction is guilty of a Class A felony.
