26	This chapter shall be known	and may be cited a	s the "Arkansas Behavior
27	Analyst Licensure Act".

29	17-108-102. Definitions.		
30	As used in this chapter:		
31	(1) "Behavior techni	cian" means a parap	erofessional who:
32	(A) Practices	under close, ongoin	g supervision of a
33	licensed behavior analyst or a li		
34	(B) Does not d	esign assessment or	intervention plans or
35	procedures; and		

1	(C) Delivers services as assigned by his or her
2	<pre>supervisor;</pre>
3	(2) "Certifying entity" means the Behavior Analyst Certification
4	Board, Inc., or another entity whose programs to credential practitioners of
5	applied behavior analysis are accredited by the National Commission for
6	Certifying Agencies or the American National Standards Institute;
7	(3) "Licensed behavior analyst" means an individual who is
8	certified by the Department of Health under this chapter;
9	(4) "Licensed assistant behavior analyst" means an individual
10	who is certified by the department under this chapter; and
11	(5)(A) "Practice of applied behavior analysis" means the design,
12	implementation, and evaluation of instructional and environmental
13	modifications to produce socially significant improvements in human behavior,
14	<pre>including:</pre>
15	(i) The empirical identification of functional
16	relations between behavior and environmental factors, known as functional
17	assessment and analysis; and
18	(ii) Applied behavior analysis interventions based
19	on scientific research and direct and indirect observation and measurement of
20	behavior and environment which utilize contextual factors, motivating
21	operations, antecedent stimuli, positive reinforcement, and other procedures
22	to help individuals develop new behaviors, increase or decrease existing
23	behaviors, and emit behaviors under specific environmental conditions.
24	(B) "Practice of applied behavior analysis" does not
25	include diagnosis of disorders, psychological testing, psychotherapy,
26	cognitive therapy, psychoanalysis, or counseling.
27	
28	17-108-103. Unlawful practice of applied behavior analysis.
29	(a) Unless licensed under this chapter, a person shall not:
30	(1) Hold himself or herself out to be a licensed behavior
31	analyst or a licensed assistant behavior analyst;
32	(2) Use any combination or abbreviation of the term "behavior
33	analyst", "licensed behavior analyst", "licensed assistant behavior analyst",
34	or "assistant behavior analyst" to indicate or imply that he or she is a
35	licensed behavior analyst or a licensed assistant behavior analyst; or

1	(3) Perform the practice of applied behavior analysis unless he
2	or she is exempt under § 17-108-104.
3	(b)(1) A person found to be in violation of this chapter is subject to
4	a fine of no less than five hundred dollars (\$500).
5	(2) A person licensed under this chapter who violates this
6	chapter is subject to administrative sanctions and penalties, including
7	without limitation revocation of his or her license.
8	
9	17-108-104. Exemptions.
10	This chapter does not prohibit or restrict the practice of any of the
11	following:
12	(1) An individual licensed to practice psychology in this state
13	and an individual who delivers psychological services under his or her
14	supervision if the:
15	(A) Applied behavior analysis services provided are within
16	the boundaries of the licensed psychologist's education, training,
17	competence, and scope of practice; and
18	(B) Licensed psychologist does not represent that he or
19	she is a licensed behavior analyst unless he or she is also licensed under
20	this chapter;
21	(2) An individual licensed to practice other professions in this
22	state and an individual who delivers services under his or her supervision,
23	<u>if the:</u>
24	(A) Applied behavior analysis services provided are within
25	the boundaries of the licensed professional's education, training,
26	competence, and scope of practice; and
27	(B) Licensed professional does not represent that he or
28	she is a licensed behavior analyst unless he or she is also licensed under
29	this chapter;
30	(3)(A) A behavior technician who delivers applied behavior
31	analysis services under the extended authority and direction of a licensed
32	behavior analyst or a licensed assistant behavior analyst.
33	(B) A behavior technician shall not represent themselves
34	as a professional behavior analyst and shall use titles that indicate their
35	nonprofessional status, such as "ABA technician", "behavior technician", or
36	<pre>"tutor";</pre>

1	(4)(A) A caregiver of a recipient of applied behavior analysis
2	services who delivers those services to the recipient under the extended
3	authority and direction of a licensed behavior analyst or a licensed
4	assistant behavior analyst.
5	(B) An individual under subdivision (4)(A) of this section
6	shall not represent himself or herself as a "professional behavior analyst";
7	(5)(A) A behavior analyst who practices with nonhumans,
8	including applied animal behaviorists and animal trainers.
9	(B) An individual described under subdivision (5)(A) of
10	this section may use the title "behavior analyst" but shall not represent
11	himself or herself as a licensed behavior analyst or a licensed assistant
12	behavior analyst unless licensed under this chapter;
13	(6)(A) A professional who provides general applied behavior
14	analysis services to organizations if those services are for the benefit of
15	the organizations and do not involve direct services to individuals.
16	(B) An individual described under subdivision (6)(A) of
17	this section may use the title "behavior analyst" but shall not represent
18	himself or herself as a licensed behavior analyst or licensed assistant
19	behavior analyst unless licensed under this chapter;
20	(7)(A) A matriculated college or university student or
21	postdoctoral fellow whom applied behavior analysis activities are part of a
22	defined program of study, course, practicum, internship, or fellowship and
23	are directly supervised by a licensed behavior analyst in this state or a
24	qualified faculty member.
25	(B) An individual described under subdivision (7)(A) of
26	this section shall not represent themselves as professional behavior analysts
27	and shall use titles that clearly indicate their trainee status, such as
28	"student", "intern", or "trainee";
29	(8) An unlicensed individual pursuing experience in applied
30	behavior analysis consistent with the experience requirements of the
31	Department of Health if experience is supervised in accordance with the
32	requirements of this chapter;
33	(9)(A) An individual who teaches behavior analysis or conduct
34	behavior-analytic research if the activities do not involve the direct
35	delivery of applied behavior analysis services beyond the typical parameters
36	of applied research.

1	(B) An individual described under subdivision (9)(A) of
2	this section may use the title "behavior analyst" but shall not represent
3	himself or herself as a licensed behavior analyst or a licensed assistant
4	behavior analyst unless licensed under this chapter;
5	(10) A behavior analyst licensed in another jurisdiction or
6	certified by the department to practice independently and who practice in
7	this state for no more than twelve (12) weeks within a calendar year; or
8	(11)(A) An individual employed by a school district performing
9	the duties of his or her positions.
10	(B) An individual described under subdivision (11)(A) of
11	this section shall not:
12	(i) Represent himself or herself as a licensed
13	behavior analyst or a licensed assistant behavior analyst unless licensed
14	under this chapter; or
15	(ii) Offer applied behavior analysis services to any
16	persons or entities other than his or her school employer or accept
17	remuneration for providing applied behavior analysis services other than the
18	remuneration he or she receives from his or her school employer.
19	
20	17-108-105. Licensure.
21	(a) Each applicant for licensure as a licensed behavior analyst shall
22	submit to the Department of Health:
23	(1) An application;
24	(2) Appropriate application fees as determined by the
25	department;
26	(3) Evidence that the applicant has successfully completed a
27	criminal background check; and
28	(4) Evidence of his or her current certification as a board
29	certified behavior analyst or a board certified behavior analyst-doctoral
30	verified by the department with the certifying entity.
31	(b) Each applicant for licensure as a licensed assistant behavior
32	analyst shall submit to the department:
33	(1) An application;
34	(2) Appropriate application fees as determined by the
35	department:

1	(3) Evidence that the applicant has successfully completed a
2	criminal background check;
3	(4) Evidence that he or she is or will be supervised by a
4	licensed behavior analyst who is approved as a supervisor by the Behavior
5	Analyst Certification Board, Inc., or another entity whose programs to
6	credential practitioners of applied behavior analysis are accredited by the
7	certifying entity, in accordance with the current supervision standards as
8	existing on January 1, 2023; and
9	(5) Evidence of his or her current certification as a board
10	certified assistant behavior analyst verified by the department with the
11	certifying entity.
12	
13	17-108-106. Expiration and renewal.
14	(a) A license under this subchapter shall be granted for a period of
15	two (2) years.
16	(b) Before expiration of a license, the license may be renewed upon
17	submission of:
18	(1) A renewal application;
19	(2) Appropriate renewal fees determined by the Department of
20	Health; and
21	(3) Evidence of verification of current certification by the
22	certifying entity.
23	
24	17-108-107. Temporary license.
25	(a) A behavior analyst licensed in another jurisdiction or certified
26	by the certifying entity to practice independently who provides applied
27	behavior analysis services in this state on a short-term basis may apply for
28	a temporary license.
29	(b) An applicant for temporary licenses shall submit an application
30	and fee established by the Department of Health and evidence that their
31	practice in the jurisdiction will be temporary as defined by the department
32	in rules.
33	(c) A temporary license shall be granted only if the department
34	verifies the applicant's licensure or certification status with the relevant
35	entity.
36	

1	17-108-108. Reciprocity.
2	(a) The Department of Health may issue a license to a person who is
3	currently licensed as a behavior analyst or assistant behavior analyst in
4	good standing in another jurisdiction that imposes licensure requirements
5	comparable to those specified in this chapter.
6	(b) An applicant for reciprocal licensure under this section shall
7	have current licensure verified by the department and comply with other
8	requirements under § 17-108-105.
9	
10	17-108-109. Regulation by Department of Health.
11	(a) The Department of Health shall administer the provisions of this
12	chapter under such procedures as it considers advisable and may adopt rules
13	that are reasonable and necessary to implement the provisions of this
14	<u>chapter.</u>
15	(b) The department may adopt the Professional and Ethical Compliance
16	Code for Behavior Analysts issued by the Behavior Analyst Certification
17	Board, Inc., as existing on January 1, 2023.
