26	Subchapter 12 - A	Arkansas Anesthesiologist Ass	sistant Act

28	17-95-1201. Title.						
29	This subchapter shall	be known and may be cited as	s the "Arkansas				
30	Anesthesiologist Assistant A	<u>·ct".</u>					
31							
32	17-95-1202. Definition	ons.					
33	As used in this subcha	ipter:					
34	(1) "Anesthesic	ologist assistant" means a gr	caduate of an approved				
35	program who is licensed to p	perform services delegated ar	nd directly supervised				
36	by a supervising anesthesiol	ogist;					

1	(2) "Approved program" means a program for the education and				
2	training of anesthesiologist assistants approved by the Arkansas State				
3	Medical Board; and				
4	(3) "Direct supervision" means the on-site, personal supervision				
5	by an anesthesiologist who is:				
6	(A) Present in the office or surgical or obstetrical suite				
7	when a procedure is being performed in the office or surgical or obstetrical				
8	suite; and				
9	(B) In all instances immediately available to provide				
10	assistance and direction to the anesthesiologist assistant while anesthesia				
11	services are being performed.				
12					
13	17-95-1203. Power and duties.				
14	(a) The Arkansas State Medical Board shall:				
15	(1) License and renew the licenses of qualified applicants;				
16	(2)(A) Maintain a current list of every person licensed to				
17	practice under this subchapter.				
18	(B) The list shall show the licensee's last known place of				
19	residence, and the date and number of the license;				
20	(3) Prosecute persons who violate this subchapter and incur				
21	necessary expenses of the prosecution;				
22	(4) Keep a record of all proceedings of the board and make the				
23	record available to the public for inspection during reasonable business				
24	hours;				
25	(5) Conduct hearings regarding discipline of a licensee or				
26	denial, revocation, or suspension of a license; and				
27	(6)(A) Share information on a case-by-case basis of a person				
28	whose license has been suspended, revoked, or denied.				
29	(B) The information under subdivision (a)(6)(A) of this				
30	section shall not include the following:				
31	(i) The name of the person whose license has been				
32	suspended, revoked, or denied;				
33	(ii) The type and cause of the action;				
34	(iii) The date upon which a penalty is imposed;				
35	(iv) The type of penalty imposed; or				
36	(v) The duration of the penalty imposed.				

1	(C) The information under subdivision (a)(6)(A) of this				
2	section shall be available for public inspection during reasonable business				
3	hours and shall be supplied to licensing entities in other states upon				
4	request.				
5	(b) The board may:				
6	(1) Promulgate rules as necessary to enforce the provisions of				
7	this subchapter consistent with state law;				
8	(2) Employ personnel as necessary to assist the board in				
9	performing its function under this subchapter;				
10	(3) Establish license renewal requirements and procedures as				
11	deemed appropriate;				
12	(4)(A) Secure the services of resource consultants as deemed				
13	necessary by the board.				
14	(B) The board shall reimburse resource consultants for all				
15	actual and necessary expenses incurred while engaged in consultative service				
16	to the board; and				
17	(5) Establish license examination fees by rule.

19	17-95-1204. Licensing.				
20	(a) A person applying for licensure as an anesthesiologist assistant				
21	shall submit an application to the Arkansas State Medical Board on forms				
22	approved by the board.				
23	(b)(1) The application shall not be effective for more than one (1)				
24	year from the date of the original submission of the application and fee.				
25	(2) After one (1) year from the date that the original				
26	application and fee have been received in the office of the board, a new				
27	application and fee is required from any applicant who desires licensure as				
28	an anesthesiologist assistant.				
29					
30	17-95-1205. Application for licensure.				
31	(a) An applicant for licensure as an anesthesiologist assistant shall				
32	submit an application form approved by the Arkansas State Medical Board.				
33	(b)(1) An applicant shall obtain a passing score on the examination				
34	administered through the National Commission for Certification of				
35	Anesthesiologist Assistants.				

1	(2) The passing score shall be established by the National				
2	Commission for Certification of Anesthesiologist Assistants.				
3	(c) The applicant shall be certified in advanced cardiac life support.				
4					
5	17-95-1206. Supervisory relationship.				
6	(a) An anesthesiologist or a group of anesthesiologists, upon entering				
7	into a supervisory relationship with a licensed anesthesiologist assistant,				
8	shall file with the Arkansas State Medical Board a written protocol,				
9	including without limitation:				
10	(1) The name, address, and license number of the				
11	anesthesiologist assistant;				
12	(2) The name, address, license number, and United States Drug				
13	Enforcement Administration registration number of each anesthesiologist who				
14	will supervise the anesthesiologist assistant;				
15	(3) The address of the anesthesiologist assistant's primary				
16	practice location where the anesthesiologist assistant may practice;				
17	(4) The date the protocol was developed and the date of all				
18	revisions;				
19	(5) The designation and signature of the primary supervising				
20	<pre>anesthesiologist;</pre>				
21	(6) The signatures of the anesthesiologist assistant and all				
22	supervising anesthesiologists;				
23	(7) The duties and functions of the anesthesiologist assistant;				
24	(8) The conditions or procedures that require the provision of				
25	care by a supervising anesthesiologist; and				
26	(9) The procedures to be followed in the event of an anesthetic				
27	<pre>emergency.</pre>				
28	(b) The protocol required under subsection (a) of this section shall				
29	be filed with the board before the time that the anesthesiologist assistant				
30	begins practice with the supervising anesthesiologist or anesthesiology				
31	group.				
32	(c) An anesthesiologist assistant may perform the following duties				
33	under the direct supervision of an anesthesiologist:				
34	(1) Obtain a comprehensive patient history and present the				
35	history to the supervising anesthesiologist;				

1	(2) Pretest and calibrate anesthesia delivery systems and				
2	monitor, obtain, and interpret information from the systems and monitors;				
3	(3) Assist the supervising anesthesiologist with implementation				
4	of monitoring techniques;				
5	(4) Establish basic and advanced airway interventions, including				
6	intubations of the trachea and perform ventilator support;				
7	(5) Administer intermittent vasoactive drugs and start and				
8	adjust vasoactive infusions;				
9	(6) Administer anesthetic drugs, adjuvant drugs, and accessory				
10	drugs;				
11	(7) Perform epidural anesthetic procedures and spinal anesthetic				
12	procedures;				
13	(8) Administer blood, blood products, and supportive fluids;				
14	(9) Support life functions during the administration of				
15	anesthesia, including without limitation induction and intubation procedures,				
16	the use of appropriate mechanical supportive devices, and the management of				
17	fluids; electrolytes, and blood component balances;				
18	(10) Recognize and take appropriate corrective action for				
19	abnormal patient responses to anesthesia, adjunctive medication, or other				
20	forms of therapy;				
21	(11) Participate in management of the patient while in the post-				
22	anesthesia recovery area, including the administration of supporting fluids;				
23	<u>and</u>				
24	(12) Place special peripheral and central venous and arterial				
25	lines for blood sampling and monitoring as appropriate.				
26	(d)(1) The supervising anesthesiologist shall delegate only tasks and				
27	procedures to the anesthesiologist assistant that are within the supervising				
28	anesthesiologist's scope of practice.				
29	(2) The anesthesiologist assistant may work in any setting that				
30	is within the scope of practice of the supervising anesthesiologist's				
31	practice.				
32	(e) Continuity of supervision in practice settings requires the				
33	anesthesiologist assistant to document in the anesthesia record any change in				
34	supervisor.				
35	(f) The tasks and procedures performed by the anesthesiologist				
36	assistant shall be documented in the appropriate medical record.
