25	SECTION 1. DO NOT CODIFY. Legislative findings and intent.

27	(1) Medicare classifies a doctor of optometry as a physici	<u>an</u>

29	under state law or rule;	
30	(2) Medicare has classified doctors of optometry as physic	<u>ians</u>

3	(b) It is the intent of the General Assembly to classify doctors of
4	optometry as a physician in the Arkansas Medicaid Program and authorize a
5	doctor of optometry to be reimbursed by the Arkansas Medicaid Program for all
6	services that he or she is currently authorized to provide by state law.
7	
8	SECTION 2. Arkansas Code Title 20, Chapter 77, Subchapter 1, is amended
9	to add an additional section to read as follows:
10	20-77-148. Classification of optometric physicians.
11	(a) The Arkansas Medicaid Program shall classify doctors of optometry
12	as physicians with respect to all services that doctors of optometry are
13	authorized to perform under state law.
14	(b) The Arkansas Medicaid Program shall classify optometric physicians
15	under the physician fee schedule.
16	(c) The Department of Human Services shall apply for any federal
17	waiver, Medicaid state plan amendment, or other authorization necessary to
18	implement this section.
