24	SECTION 1. TEMPORARY LANGUAGE. DO NOT CODIFY. Arkansas Legislative
25	Study on High School Student-Athlete Publicity Rights — Creation — Duties.
26 27	(a) The House Committee on Education and the Senate Committee on
28	Education, meeting jointly, shall conduct the Arkansas Legislative Study on High School Student-Athlete Publicity Rights.

30	(b) The Chair of the House Committee on Education and the Chair of the Senate Committee on Education shall call the first meeting for the purpose of
31	beginning the study within sixty (60) days of the effective date of this act.
32	(c) The purpose of the study is to assess the need for and feasibility
33	of amending Arkansas law to create a program whereby a high school student-
34	athlete may enter into contracts and receive compensation for the use of the
35	high school student-athlete's publicity rights.

1	(d) In order to achieve the purpose of this section, the House
2	Committee on Education and the Senate Committee on Education shall evaluate,
3	study, and address the following issues:
4	(1) Best practices in other states in which high school student-
5	athletes are permitted to receive compensation for their publicity rights;
6	(2) Feasibility of paying high school student-athletes for their
7	<pre>publicity rights;</pre>
8	(3) Governance of a program regulating publicity rights
9	contracts for high school student-athletes;
10	(4) Eligibility requirements for high school student-athletes
11	wishing to enter contracts for their publicity rights; and
12	(5) Possible impacts to a high school student-athlete allowed to
13	profit from his or her name, image, and likeness, and the impact to the
14	schools and school districts attended by the high school student-athlete
15	allowed to profit from his or her name, image, and likeness.
16	(e)(1) On or before October 31, 2024, the House Committee on Education
17	and the Senate Committee on Education shall file with the Legislative Council
18	a final written report of their activities, findings, and recommendations,
19	including recommendations for proposed legislation.
20	(2) Upon filing, the Arkansas Legislative Study on High School
21	Student-Athlete Publicity Rights shall be complete.
